Party donation form

This constitution is in 5 parts. The first part contains the name of the party and preamble. The second part contains the aims and objectives, principles and philosophy, and party's policy. The third part contains the structure of the party, the provisions relating to the party's meetings and the description of party officers. The fourth part is Appendix 1 which contains the party's ambition in the areas of housing, health care, immigration, and breathprint. The fifth part is Appendix 2 which contains the party's financial scheme.

PART 1 – NAME AND PREAMBLE

NAME

1. The name of the Party is **TOUCH LOVE WORLDWIDE (UK)**.

PREAMBLE

2. Touch LOVE Worldwide (UK) is a Party founded on LOVE. It seeks to bring in LOVE-solution to politics. In today's politics, there is a vacancy for a party which does not represent just one group but represents all people, a party which recognises at its core that what happens in one part of the world affects all of the world and bears this in mind in creating policies and making decisions. All national policies affect international communities and this is more so in this age when internet connections have made the world a global village and mobility is at its highest through affordable air, land and sea travels.
3. LOVE is that energy which creates beauty in its bearer and in others, the economy which yields peace worldwide, and the investment which brings all humans together to see what they have in common, know that they are in one another and on one side with all earth beings, and recognise 'lack of LOVE' as the enemy on the other side attacking to destroy all earth beings
4. Touch LOVE Worldwide (UK) sees itself as that party which is not an interest group of a few but whose only interest is a LOVE-led society. A party which recognises the need for LOVE to take its centre place and influence every decision, every law and every policy. As a party which has the interest of all earth beings at heart, not just the interest of human beings, Touch LOVE Worldwide (UK) learns from all things for the benefit of all earth beings. It focuses on bringing change through connectivity, and highlights what all people have in common such as breath, afterbirth, womb, body, hormones, body waste, senses and the ability to recognise, raise, build, heal, lift selves and others with LOVE, silence, words, movements and stillness.
5. Touch LOVE Worldwide (UK) as a part of Touch LOVE Worldwide movement is a political party energized and led by LOVE. LOVE resource is its resource. It is for people who are tired of infighting, tired of divisions, tired of wars but committed to growing to collective LOVE-powered advancement through learning from present and past mistakes.
6. Though many things are working well in many areas in the UK, there is still a place and vacancy for LOVE to take and fill. There is a need to educate and to lead in LOVE, and to have LOVE rule every department and every organ of government. It is acknowledged that the UK is actively and increasingly moving in the direction of a LOVE-led society with laws encouraging people, corporations and other entities to be more attentive, more sensitive and more humane; to share their spaces with those who need space, and to increase charitable acts. LOVE is increasingly being recognised by the populace as that energy which creates good working relationship in businesses, reduces work-related illnesses, produces inspiring and enriching work and home environment, and activates nourishing interpersonal philosophy. Many now recognise LOVE as a meaningful wealth, a needed skill and a vital core.
7. The word LOVE is gradually permeating all sectors including commercial businesses as a priceless resource and is now easily encountered in many establishments. Touch LOVE Worldwide (UK) seeks to highlight this development and make LOVE one of the central topics of discussion in UK politics and in UK businesses. It is the movement which put up the daily quotes ending with "LOVE TO ALL ALWAYS" seen at Earls Court Tube Station's information whiteboards from August 2016 to March 2017. This unprecedented happening highlights the way commercial

institutions are beginning to embrace LOVE and assimilate its importance. Happenings around the world have confirmed that there is a need and a vacancy for LOVE in commercial businesses, in education, in international relations, in politics and in all non-commercial enterprises and dealings.

8. The party proceeds from the premise that change starts from adopting a new philosophy. If the new philosophy is LOVE then the change that will be seen will be LOVE. This is why the Party is rooted in the philosophy known as **Touch LOVE** which recognises and highlights that energy known as LOVE. The energy called LOVE is that energy which lifts spirits high and powers the body to do extraordinary beauty-laden work. The philosophy places great emphasis and value on the uniqueness of every individual; seeing every individual as an organ of government and an organ of LOVE, capable of playing own part in creating a better world for self and for others. Where healing is needed an organ of LOVE can heal self and others through own or collective LOVE resource.
9. Touch LOVE Worldwide (UK) recognises that making and learning from mistakes is a fundamental learning curve to any advancement. Therefore, the founding members of this Party have not come together because they are perfect but have come together knowing that they are mistake-makers who are willing to allow LOVE to make them better and who are willing to put LOVE in the centre of political discussions and highlight the fact that a society ruled by LOVE is the greatest achievement of any political era.

PART 2 – AIMS AND OBJECTIVES, PRINCIPLES AND PHILOSOPHY, POLICY

AIMS AND OBJECTIVES

SUPREMACY OF LOVE

10. The Party's primary purpose is to install the rule of LOVE in the UK through legislative process. The Party intends to stand for election in all UK elections and be elected by an informed populace who recognises the Party's policies, principles and philosophy of Touch LOVE as a breath of fresh air, a much-needed alternative, a new direction presently unavailable anywhere in the world and a blueprint to build on, adopt, practise and be held accountable to, thereby, providing a reference model for other parts of the world.

11. The Party seeks to persuade the UK populace and hopes that the populace will openly choose to collectively tackle lack of LOVE at its roots by instituting LOVE as the leader in all things. UK has always been at the forefront of important innovations and there is no innovation more important than LOVE-led and LOVE-radiating innovations. Creating internal UK policies without factoring in what is happening in other parts of the world is to create a policy which does not serve the present. What happens in the UK affects other parts of the world and vice versa. When LOVE happens in the UK, it will impact the other parts of the world. There is already clear signs that both the UK and worldwide populace are tired of politics of combat and tired of war, and are already welcoming as timely, this new feature in politics. People want LOVE in power and are embracing LOVE-powered changes and LOVE-powered politics.

12. The Party recognises the causes, complexities and difficulties deep-rooted in diverse world problems and politics, but takes as its starting point the simplistic view that lack of LOVE is the worst poverty; a lack and an enemy which destroys the entity it inhabits, a disease which attacks entities and all around the entities. Entities in this respect include individuals, institutions, establishments, corporations, organisations, groups, communities, societies and countries. It is therefore the Party's primary aim to expose, out and shame that disease known as lack of LOVE so that people may see it

for what it is and rally together to forge an unbreakable LOVE-alliance, utilising LOVE resources which energise and raise human minds and intelligence, to advance far above and beyond the mundane and divisive, into LOVE-powered ways which benefit not just one group or part of the world but all individuals and communities.

13. The Party sees LOVE as the greatest resource and aims to persuade the populace to vote for LOVE at every UK election and to adopt the supremacy of LOVE in private and public dealings. People will be encouraged to vote for and support the creation and passing of a new legislation which will give legal effect to the rule of LOVE.

14. The Party recognises that in every entity exists a 'lack', a 'have' and a special kind of hormone called 'territory'. Lack of LOVE is the worst kind of lack whilst overflowing LOVE is the best kind of have. There are levels of lack of LOVE and levels of 'fill of LOVE' including 'overflowing LOVE'.

15. The Party's view is that the greatest resource is LOVE and at some point or another, there is lack of LOVE within an entity attacking the LOVE resource within that entity using different guises, shapes, faces and ideologies. Lack of LOVE can appear in any form and can penetrate any form. 'Territory' plays a significant role in creating a condition and level of LOVE or a condition and level of lack of LOVE in an entity. It is how 'territory' is fed and what it is fed which creates the condition and levels of lack of LOVE or fill of LOVE. Territory is the great divide under which every other divide falls. The great divide exists within every entity and creates both personal boundaries and other boundaries. Within every human is that hormone called 'territory' and that resource called LOVE.

16. To vote for LOVE is to vote to LOVE; to vote to increase the LOVE resources within self and within own world, and to maintain the state and condition of overflowing LOVE when that level is reached. The Party therefore seeks a support base of voters who engage with and share the Party's passion for a LOVE-ruled country. Voters will be encouraged to question their own individual role in self, collective and corrective governance. The party aims to have enough members of parliament or enough influence in parliament to pass a new legislation - 'Touch LOVE Act' which establishes the rule of LOVE and makes LOVE the overriding principle, policy and practice in all activities and in all existing and future UK laws.

17. As to the meaning of LOVE within the intended new legislation, LOVE is that core energy and sustenance which beautifies, lifts, heals and builds not just one section of a community but all of a community whilst expanding in beauty to accommodate, lift, build, heal, beautify the minds and lives of all it touches. LOVE is the highest form of intelligence and its energy creates the highest form of beauty. Sections and schedules of the Act will create instruments of LOVE. An instrument of LOVE can be in any form including art, space and word but it is that form which advances LOVE, builds bridges of LOVE and understanding across the world, heals communities and beautifies minds.

18. The new legislation will highlight the fact that a LOVE-powered advancement is unprecedented and an innovation which will advance generations into a more peaceful and more LOVE-nourishing experience and co-existence. There will be a section and schedule of the Act which will encourage individuals and governments to be at the forefront of this innovation. The form of legislation the Party has in mind is as follows:

Upon realizing that

(1) LOVE is an inexhaustible energy which creates beauty in the world and peace in minds;

- (2) To LOVE always is the greatest wealth in that it is the wealth which an one takes wherever one goes as it is built in the mind, creating a wealthy and a healthy mind which creates a healthy society of LOVE-wealthy minds;
- (3) To LOVE is an inalienable right which each being can exercise at all times and create beauty endlessly, building and healing self and others;
- (4) LOVE is the core beauty of every earth being

It is hereby enacted this [date] that:

- (a) There shall be a Department of LOVE with the sole responsibility of
 - i advocating LOVE ALWAYS;
 - ii creating spaces which nurture and nourish minds with LOVE;
 - iii overseeing collective compliance of LOVE goals;
 - iv carrying out LOVE research for the furtherance of a deeper understanding of LOVE for the purposes of channelling development of intellect and communities through the inexhaustible energy of LOVE; and
 - v creating materials for the teaching of LOVE at all levels from ante-natal clinics whilst continually developing instruments of LOVE in the UK
- (b) There shall be a Department of Religion with the sole responsibility of building bridges of understanding between diverse religions in the time of peace so as to prevent incidents of war and hostility caused by lack of LOVE taking the guise of religious misunderstanding
- (c) The UK recognises the supremacy of LOVE in all things. For this reason, the overriding objective of all UK law is to advance LOVE in all its variety, shapes and diversity; treasuring what all beings have in common whilst recognising and supporting the development of individual uniqueness for the benefit of all, thereby, creating auras of LOVE, nationally and internationally.

19. Anchored to the aim of installing the rule of LOVE, are the following aspirations:

- a To create jobs through providing affordable accommodation as part of community-based project known as a LOVE village;
- b To create a new government Ministry known as the Department of LOVE which will be in charge of EARTH BEING LOVE including Human LOVE;
- c To work with the Department of Education to create a LOVE-based educational system within the existing curriculum;
- d To work with stake holders to rethink models of economic growth and implement a LOVE-based policy for economic advancement. Every entity is a stake holder including individuals;
- e To create alternative immigration solution and implement Touch LOVE policies in immigration law;
- f To introduce the concept of breathprint to everyday living and measure success by its standard;

- g To tackle violence at its root and implement an additional law designed to reduce incidents of violence utilising any learning from breathprint researches;
- h To build and support bridges of understanding which will inspire meaningful and healthy individual and collective association, mind-expansion and co-accommodation. "The Party uses the word "Co-accommodation" as it highlights the fact that when we are open-minded, we are the earth and accommodate one another just as the earth accommodates us all. The word 'tolerance' does not reflect this fact and assumes that one is 'entitled' and the other is to be 'tolerated';
- i To work with other political parties to change the way campaigns are run, reducing to extinction the politics of hostility and combat but promoting to admiration the politics of solution, garnering support for the rule of LOVE and the proposed Touch LOVE legislation;
- j To establish TOUCH LOVE CENTRES in every community and to persuade individuals, institutions and corporations to assist in building and maintaining TOUCH LOVE CENTRES in their local communities;
- k To use 'theatre of conversation' to reduce isolation of individuals and inspire friendship within and across communities;
- l To highlight the beauty of inclusivity of diverse personalities;
- m To learn from and be like other earth beings including wild plants which generously spread their seeds and produce without worrying about copyright and to openly express ideas for the purposes of inspiring solutions and not be afraid that another Political Party will implement the good idea and claim credit for it;
- n To inspire the creation of solutions to the problem of shortage of homes and shortage of space for small businesses including art businesses. To encourage individuals and entities to participate in helping to create affordable homes and affordable business accommodations;
- o To use 'theatre of conversation' to inspire individuals to engage with ways to care for themselves to reduce incidents of falling ill and prevent avoidable serious illnesses;
- p To create awareness of the fact that preventing self from falling seriously ill is a way of showing care and consideration to health, emergency, policing and other staff of public services who get involved when things go terribly wrong;
- q To emphasise the important role pregnant women can play in shaping the future and to create a forum where children can publicly express their understanding of politics and governance and voice their opinions and offer solutions;
- r To establish an independent ministry to lead, encourage and coordinate all LOVE developments in the UK. To inspire and encourage people to make LOVE the foundation of everything they do;

- s To encourage people to openly discuss the concept of ‘afterbirth worldwide’ and motivate them to participate in the performance and discussion of the concept of ‘life of pregnancy’;
- t To encourage businesses and other entities to engage with the concept of ‘life of pregnancy’;
- u To remain alive to the fact that mistakes will be made along the way but will continue to make a way anyway. To make a start, build on the start even if the start is a mess, and grow through all mistakes. To ensure that obstacles will not be allowed to stop the carrying out of the project of instituting the rule of LOVE;
- v To put the following questions to the members of the public including those applying to join Touch LOVE Worldwide (UK) as active members:
 - i Will you join the movement of LOVE?
 - ii Will you vote to change whatever part of your own mindset is not LOVE to become LOVE which LOVES all?
 - iii Will you work to change yourself to become the LOVE you want to see in others; recognizing that the faults you see in others mirror some of your own imperfections?
 - iv Will you join in researching your own community to find out what the present generation and all ancestors did well which we should emulate and be bold to realize what they did badly which we should not repeat?
 - v Will you give room to hear a diversity of thought knowing that it is a beauty of the earth to have both minds which do not always agree and minds which always meet on points?
 - vi Will you research the food that worked well in powering the LOVEintellect and the food that poisoned all on its path which we must put away?
 - vii Words are food, habits are food and so are acts. Will you join the movement of Touch LOVE?
 - viii What talent do you have?
 - ix What talent can you use to lift spirits on your path?
 - x Will you carry a placard of LOVE which has been called a mess and create beauty out of any mess?
 - xi If given a chance at the general election or at any election, will you vote for LOVE; will you vote to LOVE, to LOVE for LOVE sake only?
 - xii Will you be at its fore-front and vote for the rule of LOVE?

xiii Do you subscribe to the supremacy of LOVE?

xiv The Party aims to make LOVE visible at all times, and puts LOVE at the core of greetings. Do you subscribe to using one or more of the following as part of your individual or corporate greeting:

LOVE TO ME ALWAYS

LOVE TO YOU ALWAYS

LOVE TO ALL ALWAYS

TO ALL EARTH AND NON-EARTH BEINGS ALWAYS

LOVE LEADERSHIP

20. The Party is determined to contest to win elections in all parts of the UK and aims to be LOVE-led by focusing on how to meet fundamental needs without engaging in verbal attack, aggression and fight with people who have different views, to encourage political parties and the populace to bridge divides and to vote for the rule of LOVE, persuading all people to give up the politics of combat and cultivate team spirit across all divides, seeing one another as part of a team of people wanting to do the best for self and others.

21. Diversity of views is a human condition, a beauty and a privilege which the Party honours, values and celebrates. Politics is a word which can be made into an action of choice. If people choose to make politics LOVE, that is what it will be.

22. LOVE is able to transform into LOVE anything it touches. Human history has made politics a war zone but there is no doubt whatsoever that when many like-minded individuals come together to make politics LOVE, politics will be transformed and LOVE will rule. People have the ability to choose to move away from fighting spirit and move into LOVING spirit. LOVING spirit is the spirit of creation which creates beauty in minds and which accomplishes what was previously thought to be impossible. It is the spirit which can transform and create beauty out of a mess.

23. The Party aims to contribute ideas to change the inherited divisive political practices which prevent growth in the direction of collective LOVE-energised advancement. Ideas will be put forward to influence the implementation of ideas which will reduce incidents of ‘unwanted disconnection’, reduce homelessness, prevent accommodation crisis, inspire self-help and prevent illnesses thereby reducing the pressure on hospitals and emergency services.

24. With respect to ‘unwanted disconnection’, the Party is dedicated to finding better ways to reduce unwanted isolation by exploring ways and policies to meet the basic needs of:

- Conversation
- Engagement
- Interaction
- Endearment
- Mind-enrichment
- Story-sharing
- Expanded inner LOVE resource
- Interpersonal connection

25. To balance the proliferation of eating places on the high streets which enrich and expand the body, the Party aims to install LOVE-philosophy conversation points on high streets to connect people, lift spirits, enrich thoughts and expand the minds. In warm weather, open-air talking points will provide outdoor philosophy platforms with the objective of connecting people from diverse intellectual and mind locations.

26. The Party aims to inspire and motivate the creation of a friendlier and more connected society which is conducive for individual and collective growth, an enabling society where people use what they are and what they have to create what they need.

CRIME REDUCTION

27. In its bid to reduce crime, the Party will learn from around the world what has worked and under what circumstances. The Party will explore new ideas to reduce crime including giving courts new sentencing powers in violent crimes. A culture of low crime rates, high happiness ratings, enriching deep-rooted individual connection, independence of thoughts, harmonious co-existence, community connection and freedom of association will be cultivated. Appendix 1 to this Constitution gives more details about this ambition.

28. To heavily invest in crime prevention by sowing the seed of LOVE in every space and nurture it to grow into a world-wide network of LOVE, connecting all shapes of LOVE and planting the rule of LOVE in every mind. When LOVE rules minds, rules expressions and actions, there will be a reduction of people harming others through pent-up anger, resentment and other negative emotions, and this will reduce many conflicts and many incidents of violence.

TAX

29. To explore a new system of 'tax' including giving 'tax' a new name which will reflect the reasoning behind the financial contribution. The Party will propose the adoption of the term 'LOVE' in place of 'tax'. The new system will include requiring entities and individuals to participate in community service as part of meeting 'tax' obligations. Community service will include providing space to people in the community to use free of charge for certain approved works, hosting training, teaching skills to people who need to learn new skills, collaborating and being part of 'THEATRE OF CONVERSATION' sessions. Individuals can take time off their paid jobs to participate in community LOVE developments including the construction of LOVE villages, the creation of 'breathprint' apps and other community LOVE developments. Just as individuals who represent trade unions take time off their paid employment to work for their trade unions, every worker who is called upon to do LOVE community service, will be statutorily permitted to work on the LOVE development and such LOVE work can either count towards meeting the individual's 'LOVE' obligation or the employer's 'LOVE' obligation or both. Self-employed individuals including carpenters, plumbers and electricians will be part of this.

30. The Party will seek to work with sports centres and gyms so that community projects can be used as part of fitness activities. Individuals will be encouraged to work in community LOVE projects, spending the energy they will normally spend in the gym.

POVERTY REDUCTION

31. When people hear 'poverty', they immediately think of lack of money but lack of money is not the only poverty neither is it the worst poverty. The worst poverty is lack of LOVE and that is the poverty the Party aims to reduce because it is the root and route of all other poverties. The Party is intent on highlighting the dangerous state of lack of LOVE as the worst poverty so that when people hear poverty they will think of lack of LOVE instead of thinking of lack of money.

32. 'Poverty' or 'poor' refers to any lack, needs, wants, hunger, absence, dearth, depletion and deficiency including LOVE deficiency at any one time in that store called the mind. The Party aims to highlight the fact that everybody is poor and wealthy at the same time because everybody lacks one or more things and what makes one poor presents one the opportunity to create and grow. Inner LOVE resource is wealth which can be increased and used to meet needs.

33. 'Lack' is an important state of being because it activates the survival hormone which drives the body and triggers creativity. Lack of knowledge, for instance, is a state which can trigger research and lead to the acquisition of knowledge. Lack is a landscape which is never static. In its very nature, it is a changing and changeable state which is fundamental to human advancement, human existence and healthy human responses such as moderate stress and anxiety.

34. The mind as a storage which is the abode from which creativity proceeds can lack or have. A mind in a poor state can create destruction if the resources stored in the mind and activated by the survival hormone are of destructive nature. A destructive nature is any nature which drives a person or a people to destroy. Destruction starts with and includes personal inner mind wars which spill into outside wars and walls. It also includes self-destruction and the destruction of others with words, behaviour, attitude, acquisitions and investments. Behaviours which damage, harm or annihilate self or other earth resources and species, including destruction of human resources, destruction of forests, the poisoning of air and water, and the depletion of inner LOVE resources fall into destructive nature.

35. If the mind's storage is filled with LOVE and beauty, its emanation does not destroy, but instead lifts self and others above destruction. A non-destructive nature develops and expands inner LOVE resource and radiates in all directions to connect individuals and societies. It creates ventures and experiences which lift, build and nourish own spirit to give a collective high. Because poverty is a changing state, it is not the exclusive privilege of one individual or group of individuals but equally distributed across all individuals.

36. If the poverty known as lack of LOVE is reduced, the poverty known as lack of money will also be reduced because the cause of lack of money would have been tackled at its root and route. For instance, it is lack of LOVE which causes war which creates all kinds of poverties including lack of money.

37. The Party recognises lack of LOVE as an infectious disease which kills a society, a poverty which destroys generations, a disabling condition which stalks to kill and the worst human condition because it eats and destroys the heart, the mind and core, and holds its victim a prisoner in a damaged but infectious poisonous state of existence and consciousness, oozing pain and destruction with every heartbeat.

38. The Party recognises LOVE as the greatest wealth, the greatest intelligence and the greatest energy. LOVE's energy lifts the spirit high and gets the body to arise and do what was once thought to be impossible. LOVE is profound and needs no introduction to a being who is LOVE at the core. What needs introduction is the philosophy of Touch LOVE which recognizes LOVE as being over and above law, so makes LOVE the overriding principle and objective in all acts, decisions, expressions and investments for the purposes of individual and collective advancement. When LOVE rules all minds, law will become obsolete. LOVE lifts spirits and gives confidence. Destructive insecurity has no place in a mind secured by LOVE. A mind secure in LOVE is ruled by LOVE.

39. Death of the LOVE connection point within is a preventable death. Any blockage can be unblocked. Many past and present philosophies feed on the human need to extend and prolong life here and elsewhere. However, what humans can indisputably prolong on earth is the LOVE they bear. That LOVE can be planted, and when planted and nurtured, outlives the body and expands endlessly.

40. Humans are intelligent enough to now realize that lack of LOVE is a disease; a preventable poverty and a preventable death. It is an infectious disease and death which kills not just its victim but can also kill others in the victim's world. Lack of LOVE assumes faces and names such as revenge to wreak havoc. When lack of LOVE is seen as the disease, the poverty and the death which it is, people will see being filled to overflowing and erupting proportion in LOVE as the beauty which transports the spirit to a place of beauty and gets the body to do what was once thought of as impossible, a state of beauty which is achievable and enjoyable here on this awesome and beautiful earth.

41. The Party proceeds from the view that the real poverty which destroys a people and a nation is the depravity, the deprivation and poverty lurking deep within but appearing to be seen in acts of destruction including destructive words, hostile attitude and annihilation of self and others. This poverty sometimes exploits fear including fear of the unfamiliar and of the unknown which it uses to isolate and incapacitate people and annihilate integration. It is this poverty which causes destructive divisions, intolerance, different types of human-made destructions, and pursuit of power at all costs. If this poverty is tackled collectively at its root through acts and instruments of LOVE, the places at war will know peace, unsafe parts of communities will be safe, and the world will be a better and happier place to live, to work and to tour.

WIWEC

42. The Party aims to stir people's intellect to rethink their own understanding of Wisdom, Intelligence, Wealth, Energy and Core (WIWEC) through exploring the idea of LOVE in all things.

43. LOVE is the wisdom which enriches without destroying, so the party seeks to enthrone the wisdom of LOVE and dethrone whatever that is not LOVE. A common enemy to all people is lack of LOVE and it is lack of LOVE and its products which destroys all on its path, creating war and its likes. When a community is full of LOVE, spirits are lifted high, people maintain appropriate distance whilst being connected and minds are healthier.

44. LOVE is the intelligence which the party seeks to highlight through education and encourage from ante-natal clinics. The intelligence of LOVE sees self in others and others in self and creates a happier community.

45. LOVE is the greatest wealth because it enriches the mind with beauty and creates a beautiful active, creative and LOVE-connected community. Through its 'THEATRE OF CONVERSATION', the party seeks to increase the wealth of LOVE by planting more LOVE installations in every UK community to increase understanding and prevent conflict.

46. LOVE is the energy which powers and is power. Its power lifts spirits above burdens, obstacles, the mundane and gets the body to arise and do what was once thought to be impossible. The party aims to create a rethink of the meaning of power and to encourage people to see LOVE as the greatest power worth increasing as it is not destructive but heals self and others.

47. LOVE is at the core and centre of all human needs and politics. The party makes LOVE its core and guiding philosophy in all activities, and seeks to inspire the delivery of services through the platform

and spectacle of LOVE. When people vote for the party at any election, they are in actual fact, voting for themselves to be leaders in LOVE, to be accountable to LOVE, accountable to every breath inhaled, making LOVE count in every account.

PREGNANT WOMEN AND CHILDREN

48. Pregnancy is a most sensitive condition of any being. It is that state of being when all protective and survival instincts and hormones are engaged fully at work. A society which approaches governance through the eyes of pregnancy will be sensitive, progressive, caring and LOVING not just of the now but of the future. The Party's core value is rooted in the fact that it approaches governance through the eyes of pregnancy, seeing everybody as pregnant, needed and important. A Party which values pregnancy connects all pregnancies and afterbirths; past, present and the future. By approaching policies and governance through the eyes of pregnancy and placenta, the Party homes into what all people have in common, recognises the contribution of all earth forms including the land which provides food, and values the importance of each and every being on earth not just human beings.

49. The Party aims to highlight the important role pregnant women can play in moulding the future and highlight the intelligence of children and their potentials as LOVE-led leaders of every society. To create awareness of the philosophy of Touch LOVE which if taught from ante-natal clinics, will position pregnant women as core LOVE-leaders and pave the way for unborn children to lead in achieving a world ruled by LOVE. In a democracy, every individual is a politician and a government, therefore, children must be enabled to take their place in governance.

50. The Party aims to create policies which will enable the educational system to simplify and teach governance so that children can learn essential politics as a compulsory subject from as early an age as possible as, just as they learn mathematics and other core compulsory subjects.

51. Governance needs to be taught in an exciting child-friendly age-appropriate captivating way so that children can be given from very early in life the tools to effectively question government decisions. Leaving politics out of the early years of the school curriculum is to continue to make essential politics an alien subject to many adults. Adults who did not grasp essential politics as children do not easily understand politics and many lose interest and hardly grasp the workings of government.

52. Children learn at home which is why some families produce many politicians when others do not. Not every family has adults who discuss politics around children. Politics is not as difficult as mathematics, so, there is no reason why children should not be taught essential politics from very early on especially as political decisions have a direct impact on children's lives. The Party aims to simplify politics, make politics easily accessible to all, highlight the fact that governance starts in self and if each allows the LOVE within self to govern the instincts in self, destructive instincts will be curtailed. Destructive instinct is that enemy breeding lack of LOVE and lack of LOVE is that enemy which destroys self and others.

53. Every individual is to be inspired to recognise own leadership skills, and follow own LOVE-leadership; leading own self in LOVE by leading own self out of what is not LOVE into all that is LOVE.

LOVE STOPS

54. There is LOVE-energy within every individual which can be activated. When activated, it radiates to create beauty not only in the mind, body and condition of an individual but also lifts a

community into a place of beauty. Creating awareness of this LOVE-energy and inspiring individuals to research it and explore ways to tap into it is part of the Party's aim.

55. One of the Party's objectives to create 'LOVE stops' and 'LOVE-energy' filling stations in prominent and non-prominent parts of local communities where the 'LOVE stops' will be encountered unexpectedly like one encounters wild flowers. 'LOVE stops' and 'LOVE-energy' filling stations are places where people can stop to refill their LOVE tanks as cars are stopped to refill their fuel tanks. A LOVE stop will have many inspiring, healing and building features. These will include philosophical installations designed to make people think about the important role LOVE plays in personal and collective advancement and wellbeing.
56. 'LOVE stops' will also stir minds to open and consider how to tap the inexhaustible LOVE energy. LOVE stops are intended to be meeting points for minds of all ages and promote the rule of LOVE. The rule of LOVE develops and increases inner LOVE resources; transforming instincts to LOVE and creating beauty which benefits self and others including non-humans.
57. The Party aims to be a rallying party which brings a community together to see the value of expansive and accommodating LOVE spirit, commonality, variety, uniqueness and diversity. 'LOVE stops' offer creative and mind-enriching alternative ways of doing things; being a purveyor of inspiring ideas which will stir the LOVE energy of the populace and motivate individuals to participate in government by opening up their LOVE reserve and governing own self with LOVE-resource.

PRINCIPLES AND PHILOSOPHY

RALLYING CALL

58. The Party approaches the world through the eyes what all humans have in common including pregnancy, the unborn, the living and even the dead and lessons left behind. It places weighty emphasis and focus on the important role pregnant women can play in shaping the future.
59. From time immemorial, what happens in one part of the world has always affected other parts of the earth. The age of the internet has made the world a connected listening entity where what happens in one part is immediately known in another. In a world so connected, disconnection still appears in different forms to become a problem plaguing individuals and communities. Many people need conversation and feed this need through social media. There is legitimate concern about the long-term physical and psychological implications and consequences of our reliance on computers and hand-held devices and how this might impact our future. Staring at screens may impact future human shape and shape the future. It is within this context that the Party's activities are a rallying call to people in the UK, a call which echoes around the world, a call to all people to invest in LOVE.
60. LOVE is intelligence and there are many people who are LOVEintelligent. The Party is, therefore, a rallying call for all LOVEbearers and all LOVE-intelligent people to come together and institute the rule of LOVE. If people can train dogs and horses to do great things, they can equally tame their own raw, and mould it to LOVE. All it takes is a change of mind and a focus on LOVE.

MISTAKE MAKERS

61. The Party understands that everybody makes mistakes and people are mistake makers who can learn and grow through getting things wrong. The Party therefore approaches mistakes with a certain kind of respect and sensitivity, being kind to mistake makers and learning from all mistakes.

SHAPES OF LOVE

62. The Party's philosophy is that each earth being is a shape of LOVE with the power to LOVE. The power of LOVE is the greatest power because it can heal self and others, create a life, save lives and beautify a community. If all come together to collectively put LOVE in power as beings with a common purpose, and as beings who exhale their DNA into the collective pool of air which all share in common, a start can be made into tapping into the inexhaustible LOVE energy, mistakes will be made in the process but such mistakes will lead to a better understanding of the inexhaustible LOVE fuel and will yield a LOVE-induced growth.

63. Touch LOVE philosophy recognises the strength of individual uniqueness in collective advancement. Every individual is a life force of LOVE with profound potential to build great beauty out of great mess, heal self and others and lift spirits high into that much sought after euphoric state of LOVE. When the LOVE within is touched, it is activated to glow, radiate, expand, ripple, vibrate, beam and energise both individual and collective LOVE-propelled advancement.

64. Rooted in the philosophy of Touch LOVE, the Party recognises the uphill task it faces as a movement which seeks to unset minds which are already set on habitual ways of thinking about wealth, intelligence and power. Power struggle has become a sport in political arenas, a sport of trading insults and blows, and people have become accustomed to the overtures of this way of doing things and are excited to partake. Political parties often take sides to destroy the opposing side in a game which entertains the populace spectating a political arena which is far more populated than the most populate Premier league football arena. These inherited traits of entertaining human spirits with divisive philosophies have been handed down from time immemorial and will not be easy to unseat.

SUPER POWERS

65. Tapping the inexhaustible LOVE-resource will create a world where no one is seen as superior and another inferior. The present is full of many claiming to be superior and looking down on others who do not think as they think. Many books and past stories create this way of thinking. Tapping into the inexhaustible LOVE-resource will create a world where the super power is LOVE, the role models are the air we breathe, the teachers are the **herbs** which heal, the **plants** and flowers which beautify our paths, the lifting scents on our paths which plant smiles to blossom on our faces and touch our spirits with beauty.

66. Humans have the ability and capacity to achieve a world where beauty of mind is the wealth; where diversity of thought, variety of uniqueness and multiplicity of creativity are seen as the universal language to be celebrated; where LOVE is recognised as the greatest intelligence; where harmony of individual uniqueness is valued; and where a world's super power is a group which has never been to war, which has never been part of a war, which has never exported weapons of any kind but which continuously exports wise words which value all earth beings.

67. Many parts of the world remain at war and many others live by superiority and inferiority claims. Phrases such as 'third world countries' and 'super powers' are manifestations of these accepted

superiority and inferiority claims. Many minds ruled by claims of superiority and inferiority are insecure and use those claims to secure. Many thoughts and philosophies disconnect communities because of superiority claims which create some as inferior and others as superior, and which create factions of 'them' and 'us'. Though the internet connects many, many are disconnected and live isolated.

68. Presently, people are ruled by the thought that the greater ability a group has to kill earth beings, the more super that group's power is deemed, so communities with nuclear weapons are given the title of super powers and communities which do not seek to dominate others are looked down upon. Sayings and words which make some inferior and some superior rule in these arenas. Great value is placed on weapons of mass destruction and any group which exhibits unrivalled ability to mass destruct is immediately placed at the helm of affairs and the top of the list of 'super powers' on account of its ability to kill many and hold many to ransom due to its ability to mobilise within a very short time weapons that can kill millions in seconds.
69. Touch LOVE philosophy highlights the fact that humans have the ability and capacity to achieve a world which sees poverty NOT as lack of money BUT as lack of LOVE. It is lack of LOVE which creates annihilation of a person or a people. It is lack of LOVE which detonates weapons of mass destruction as a way of achieving supremacy. It is lack of LOVE which creates territorial economy, territorial decisions and territorial businesses which strangle life out of some whilst filling the money bank account of others.

AGE OF MATURITY

70. Humans have the ability and capacity to turn around their thoughts and individual philosophy to create and achieve a world where inner LOVE resource is valued more than money; a 'LOVE bank account' seen as healthier and more powerful than money bank account. Humans have the ability and capacity to dethrone money and enthrone LOVE to achieve a world where the legal tender and currency is LOVE and where exchange rates are measured in breaths and units of LOVE; where talents lift one another and where money does not rule but where LOVE does. Presently, human world economy is based on money, and money talks and rules, making the person or group which makes the most money the one which dominates decision making about a people's way forward. **Humans have become accustomed to this way of doing things but in terms of collective human age, humanity is still in its infancy and can grow to leave childish tantrums behind to progress to LOVE maturity.** Each individual can begin this process into the 'age of maturity'. The Touch LOVE philosophy of 'age of maturity' sees LOVE as an age, an age which matures better than a fine wine and more expanse than the sun. Only LOVE matures individuals into a state where they see the reflection of others in self and the reflection of self in others. Only LOVE matures a mind to a state and condition where the mind becomes a store of nourishing beauty to others, a store which supplies inexhaustible LOVE energy. Each individual plays a part in the concept of age of maturity, starting with questioning own individual role in the collective whole.
71. It is true that the ambition to achieve a world ruled by LOVE is profound but if people who looked at the moon and wished to reach it, managed to achieve reaching the moon, there is no doubt that people can reach deep into themselves to touch the LOVE they are to flow out and rule them. The distance to the moon is far longer than the distance to the LOVE core. The distance to the LOVE core is only a breath away and does not cost money.

OPENNESS

72. All the Party's activities are open and must remain open because it is the Party open to every individual and legal entity, every born and unborn, every pregnancy- past, present and future and every afterbirth. It is a party which puts unborn children and their pregnant mothers in charge of shaping the change which will benefit every individual. It is a Party which sees every individual regardless of gender or age as pregnant - pregnant with ideas. The Party does not use the phrase 'ordinary people' because its philosophy is that every individual is extraordinary.
73. The Party uses philosophy performances (**theatre of conversation**) to express itself and to get individuals to look at issues from diverse intellectual locations. In practice, its contribution is educational. The party is 'see-through'. It evolves in the full view of the public and its mistakes are open wounds to be healed by suggestions from anybody who finds faults and cracks in its activities.
74. Subject to the security and other legal requirements of the space in which a **theatre of conversation** is being held, every person who wishes to participate in conversation is openly admitted. The Party has a free entry policy to all its **theatres of conversation**.
75. **Theatre of Conversation** is also known as '**chamber philosophy**', a philosophy show and performance which brings people together to share their thoughts and think universally. Three volumes of an encyclopaedia of over 40 volumes have been published for the performances which have been going on in different venues in London since June 2016. The title of the book is "MANY LOVERS BOOK 4267 – A PUBLICATION OF TOUCH LOVE WORLDWIDE". **Theatre of Conversation** is also happening on Facebook with live and recorded videos which have been on the increase in 2017 dealing with diverse subjects.
76. The Party calls upon all people to vote for LOVE. It highlights the LOVE in all things, the unique energy connecting all beauties, in all things, in all earth and non-earth beings. The party seeks to work with other political parties, individuals, governments, institutions, organisations, commercial and non-commercial entities to institute the rule of LOVE.

CONNECTION WITH TOUCH LOVE WORLDWIDE MOVEMENT

77. The Party has ideological connection with the worldwide movement '**Touch LOVE Worldwide**' and draws its Touch LOVE philosophy from the philosophy of -Touch LOVE Worldwide - which recognises that what happens in one part of the world affects all of humanity and advocates that international communities must coordinate resources towards tackling the root and route of crime, corruption, economic migration and destructive greed and selfishness. The Party also shares the **movement's** concept of **Afterbirth Worldwide**.
78. **Touch LOVE Worldwide** movement has been spreading the message of LOVE through its Facebook concept of **University of Touch LOVE Worldwide**, other online and offline publications, its '**theatre of conversation**' performances and '**LOVE TO ALL ALWAYS**' installations and LOVE gardens. **Touch LOVE Worldwide** movement is non-money making and the Party has no financial interest in the movement and the movement has no financial interest in the Party. The philosophy of **Touch LOVE** including its **Afterbirth Worldwide concept** is new and creating awareness of the philosophy is a priority and this is being created through online and offline channels including Facebook. Instituting the rule of LOVE in every country is the solution the movement advances as the way forward to stopping war and other world conflicts.
79. The **movement** has been drawing attention to the fact that it is depletion of LOVE inner resource, which is at the root of the depravity causing violence, war and other human-made destructions. It seeks to garner both nationwide and worldwide support for the rule of LOVE and the rooting out of lack of LOVE. It makes a clear distinction between different lacks, emphasising that lacking money is not the

same as lacking inner peace and inner LOVE resource. Lacking inner LOVE resource is the real poverty which does not just annihilate its victim but also those around.

80. The Party and the **movement** recognise LOVE energy as an inexhaustible inner resource and inner government, and highlight the LOVE-strength of each and every individual. Both the Party and the **movement** openly make LOVE the overriding principle and objective in all decisions and investments. Resolving to make LOVE the overriding principle is the first step towards reclaiming power from the disabling and destructive state and condition known as lack of LOVE.

81. As what happens in other parts of the world affects the UK, it is hoped that the activation of the Touch LOVE principles and philosophy in the UK politics will spread the rule of LOVE to other parts of the world and create a model for other communities of the world to build on as they move to adopt the rule of LOVE and institute the supremacy of LOVE government.

82. The Party's activities constitute an open call, a rallying call and a rallying point for everyone who has chosen the rule of LOVE.

WHAT'S IN ME?

83. **What's in me** is a concept which states that LOVE is inside every individual, and successful self-governance depends on the state of an individual's inner LOVE resource. Individuals self-govern better if the level of LOVE within is high. The LOVE in an individual can govern the individual better if the individual allows it to lead the individual in all things. Successful self-governance creates successful collective governance and successful collective governance creates a happier community.

84. There are different LOVE conditions and states of being in an individual at any one time. These include:

- a The state and condition of 'full of LOVE, overflowing LOVE, erupting LOVE'
- b The state and condition of 'lack of LOVE and erupting destruction'
- c All the other different LOVE states, conditions, levels and being, in between those two

85. In every individual is a human instinct which always seeks to protect the individual and all the extensions of the individual, including material possessions, physical territory and intellectual locations and properties. This instinct is territorial and its level varies. **What's in me** concept recognises that the human core is made up of a matter called LOVE, which itself is LOVE energy which can be aroused, activated and stirred. When latent LOVE is fully activated, it can lift the body to scale heights previously thought to be impossible to reach.

86. The full in fulfilment is LOVE. To LOVE others is a fulfilment, a human need and instinct. The human instinct to LOVE others is an instinct to LOVE self and lift self high. Until others are LOVED, an individual will always want and always feel empty and feel something missing. 'Others' in this context include the earth and earth forms including trees, mountains, deserts, herbs, seas, forests, domesticated and undomesticated animals. Only by LOVING others, does the LOVE instinct achieve purpose, contentment and 'filment'. One LOVES self by LOVING others. One preserves self by LOVING others. One expands beyond the body by planting seeds of LOVE in minds and other fertile soils.

WHAT'S IN IT FOR ME?

87. LOVE can be said to be abstract and can mean different things to different people. When it comes to a political party, what some people really want to know is what the Party will do, what they will get if they vote for the Party. No doubt, this is a very important concern but also highlights the first fundamental issue. The issue of “what’s in it for me?”. Who is the Party’s policy going to lift? Us, them or everyone? What resources are available to this Party to make the proposal achievable? Where is that resource coming from?
88. In addition to those legitimate questions, the Party is inviting people to also think questions such as “what’s in me for it?”, “does this party make me think deeper about myself and the world at large?” “what inner resources do I have?”, “how big is the core of LOVE in me, the core of LOVE which I am”, “what’s in me?”, “what is my role and what service can I offer?”, “will this party provide an opportunity for me to use my talent to lift others?”, “what talent have I got to invest to make the proposal achievable?”.
89. The policies of political parties reflect the image of the concerns of the voters whom political parties believe will make a difference. Touch LOVE Worldwide (UK) is not an interest group for a particular group of voters. It is a LOVE-Party established to create policies which will benefit all voters. The interest which calls all groups and groups all humans together in one state is LOVE. So to the question, ‘what’s in it for me?’, the answer is LOVE. The Party relies on the LOVE each and every individual can offer, the skill and energy each and every individual can invest to create what they can and shape policies and the Party. What’s in it for an individual is the impact the individual can make, the legacy the individual can leave, the LOVE breathprint the individual can add to the pool of breathprints.

OWN SELF

90. To the question: “If LOVE rules, what will you get|, the answer is: **own self, own core**. This is because an individual is made of LOVE and if LOVE rules, it is that LOVE part of the individual that is in power and an individual can actually see own self and core in the policies founded on LOVE.
91. To the question: “What will people get, what will voters get if LOVE rules?”, the answer is: ‘people will get and see their **collective core in the policies centred on LOVE**. If voters vote to LOVE and enthrone the rule of LOVE, the workings and economy of a country led by LOVEpeople will be witnessed. It is not difficult to vote to LOVE because people’s core is LOVE. Individuals contributing individual LOVE to the management of own community create collective LOVE which makes a huge LOVE-led difference.
92. If we understand ourselves better, we can forge ahead much better, preventing as much as possible the repetition of the mistakes of the past. Reaching deep within to get in touch with the LOVE within is a journey which can sometimes be the most difficult journey of encounters. Sometimes, we fear what is inside of ourselves more than we fear what is outside of ourselves. Sometimes we do not want to look in the mirror because of fear of what we will see. Sometimes we point fingers at others to point fingers away from ourselves. We see ourselves in others and point fingers at ourselves we see in others because we do not like what we see. Sometimes, we are afraid to engage with ourselves and pointing fingers becomes a way of living with ourselves and diverting attention from looking deep within.

93. It is deep in self that problems reside and deep in self that the journey of change must begin. Countries bear the burden of their histories same as individuals, and must get to the root and route of those histories to begin to unravel the present and build a better future unburdened by the heaviness of a weighed down mind storing lack of LOVE thoughts, experience and injuries.
94. Countries just as humans need therapy and the Party is suggesting LOVE as a therapy for every country of the world. LOVE has proven to be an effective therapy for individuals and no doubt will work for countries better than the therapy of going to war. War is an age-old redress and therapy which is known to create more humans needing therapy and humans bearing burdens of hate passed on by enmity from years past. War is the manifestation of human infancy age and all humans must strive to advance to the mature age of LOVE.
95. LOVE is in everyone and in everything and is in the interest of the whole community and society. LOVE is part of human composition which is why strangers stop to help or call emergency services when an accident happens. The Party's starting point is at the individual level which is the level where lasting change happens.
96. **'Own Self'** concept is not about using money to dominate. It is about an individual or a country allowing LOVE to dominate. To dominate the voice which seeks to pull down the individual with words such as *'I am too old'*, by hearing the voice which lifts the individual's spirit with words such as *'I can start now'*; to dominate *'I don't want to make mistake'* by hearing *'If I make mistake, I will learn and become better'*; to dominate the voice calling own work a *'mess'* by hearing the voice which recognises that out of every mess, beauty can be created.
97. Any problem one complains about is a problem that started deep within. There is a part of every human which is destructive and which when tapped destroys. There is also a part of every human which is LOVE which when tapped, builds, beautifies, lifts and heals. The part which is LOVE can dominate the destructive part if the LOVE path within is not blocked or suppressed.
98. Human shape is a unique shape of LOVE which stores LOVE as it stores other kinds of energy including energy from food and the sun. When the LOVE in human shape is activated, it is capable of healing self and others, building self and others, transcending the limitations placed by insecurities, making the body lighter. In that light state, a body becomes like air and spirit which can permeate all things, and advance to reach that state of being a *'beauty-creating genius'*; the state in which what was previously thought to be impossible becomes fully achieved.

FORCE

99. LOVE is a system and a strong supporting stem. As the core of all things, LOVE does not force itself on anyone. Just as the oxygen in air gives of itself without discrimination to any breathing system able to draw air, LOVE gives of itself without discrimination to any human system able to recognise its potency, adopt it and allow itself to be powered by LOVE. LOVE energy is available to all individuals and it is an inexhaustible resource. If given a chance to rain and reign, LOVE will flow to create a LOVE system; nourishing human core, hearts and minds, and advancing humans into a better state where peace, creativity and productivity benefit all earth beings not just human beings.
100. Human activities including the system of war do kill, maim, and destroy other earth forms and species. Lack of LOVE is the force using different faces and arguments to persuade humans to

destroy themselves and other earth beings. LOVE is the force which raises humans and other earth beings.

101. Every individual is a solution and can flow to help achieve a society where everyone feels part and flow. The populace is a mighty force and can choose to be the mighty force of LOVE working together towards achieving a society ruled by LOVE. LOVE is the only self-interest which is a collective interest, the only medicine which heals both the giver and the healer at the same touch, equally lifting all around whilst transforming living to LOVING. The real equality is LOVE quality. The inalienable human right is the right to LOVE; the right to LOVE others in self and to LOVE self in others, the right to know others in self and to know self in others, the right to know that self is others and that others are self, the right to recognise that self is in others and that others are in self. Human right is an obligation to be air not just to be like air, an obligation to be solution not just to be like water, an obligation to LOVE as oxygen LOVES, giving life to others as air and water give. All an individual does to receive oxygen is to merely draw in a breath. Air is priceless and life-giving. Human right in drawing life-giving air creates an equal obligation to give life-giving LOVE. Unpolluted air gives and sustains life. LOVE is unpolluted air.
102. Every individual has in self, the ability to lead. To lead in LOVE and become a LOVE leader; leading own self from what is not LOVE to what is LOVE. LOVE is a journey. It is a need which earth forms have, not just the need of human form. It is a fundamental need, a kind of food, a kind of shelter, a kind of security, a kind of mobility, the only class which accommodates all and does not segregate into upper, middle or working, the state which does not create boundaries along country lines.

LOVEISM

103. The question which the Party stands for is not a question of patriotism or a question of nationality neither is it the same question as ‘what can I do for my country or what can my country do for me?’ The ‘**Touch LOVE**’ ideology calls on individuals to touch the LOVE they are and to self-govern. The ideology is not individualism. It is **LOVEism**; a question of reaching deep within to touch the LOVE inside which when touched glows to reveal the self in others and the others in self; to reflect self in the mirror called other earth beings and to see how LOVE is the core of beauty, harmony, variety, openness and diversity.
104. The philosophy of **LOVEism** is about thinking deeper to find the deeper root of surface problems. Surface issues are usually symptoms and not necessarily the roots which need to be uprooted to eradicate a problem. Starting from inner self-exploration for inner wisdom, inner wealth, inner intelligence and other inner resources, the Party veers away from finger pointing at others to deep searching of self. The Party of mistake makers cannot subscribe to finger pointing and is not interested in pointing fingers at others where it has not first pointed fingers at own self. The Party takes the view that everybody is answerable to the air inhaled and accountable to the oxygen received. The oxygen which an individual can be is LOVE, an entity giving words which lift self and others, and acting in a way which gives life and sustains a better society.

Part 3 – Articles of Constitution

Article 1 -Party Structure and Organisation

Branches

105. Party branches are called **Party books**.

106. The country is divided into '**Books**' and numbered from **Book 1** onwards. Each Book corresponds to a parliamentary constituency. Two or more active LOVEbearers can constitute a book within a Parliamentary constituency and can contact London Office to recognise them as a named book for the Parliamentary constituency in which they intend to carry out the activities of the Party. The Board members (or a majority of them) will attend a meeting with the proposed founders of the intended book and if satisfied that the proposed founders of the book are well versed in the philosophy, principles, aims and objectives of the Party shall approve and record them as founders of the proposed book.

107. A book is active and recognised only during any period when it is operating within the philosophy of Touch LOVE and the principles, aims and objectives of the Party, and at any time when it openly subscribes to this constitution.

108. Officers of each Book are elected annually to positions that include Treasurer, Secretary, Pregnancy and Placenta Officers, Chair, Vice Chair and Campaign Officers. The Party's Officers stand are both its Board and its Executive Committee with the proviso that any other member who attends the Board or Executive Committee meetings is part of that body for the day.

109. Books do not pay subscription fees. It is recognised that paying a subscription fee is easier than making an internal change, so books are tasked with the responsibility of making that change only LOVE makes.

Record keeping for books

110. Each branch will keep record of its own 'Theatre of Conversation' and other activities which can be easily viewed by any interested member of the public or a public authority or institution which calls them to give account of their purpose and activities. It is recognised that positions can be abused by lack of LOVE which can infiltrate any mind at any time and corrupt an intended good intention. The party must be alive to this fact and be transparent at all times. Branches must keep records of all activities, be ready to exhibit such records whenever called upon to do so and take all steps to unseat all acts of lack of LOVE lurking within which if not evicted will wreak havoc within the branch.

111. Active LOVEbearers give their time and skill without monetary charge. The Party is new and growing but its structure and organisation will follow the same structure as it expands across the UK.

Members of the Board – Party's decision-making process

112. The Board is the ultimate decision-making body of the Party. It is responsible for all operational matters including approving the creation of a new book, fundraising, membership and approving the nomination of election candidates. Board Members consist of all Party officers elected at the National Book Gathering but due to the Party's open door policy, any LOVEbearer can attend a decision-making meeting and contribute own ideas and vote at the meeting attended provided that prior notice is given to the Secretary of the Party at least 21 days before the meeting and the Secretary invites the LOVEbearer stating any condition as may be informed by the venue in which the meeting is taking place.

113. Decision making starts with a **theatre of conversation** which highlights an issue, invites lively sharing of thoughts on the issue before any decision is made. If all participants at the meeting do not agree, on one direction, the matter is voted on and a majority approval is required to carry any

motion to the next stage of the process. The next stage entails running the approved cause of action or matter through the LOVE-resolution process. The LOVE-resolution process entails referring to the relevant philosophy which covers the issue and ensuring that the decision advances that philosophy and the core value of LOVE upon which the Party is founded. After the LOVE-resolution process, reasons must be openly expressed by the Chair of the meeting as to why the chosen course is in conformity with the Touch LOVE philosophy and principle.

114. If the course of action fails the LOVE-resolution process, then the course of action must be abandoned or reformulated. If reformulated, the amended form must pass through the same process. Every book must follow this process and must have a chair and secretary who must report directly to the Party board after the theatre of conversation and the decision of every book must be approved by the board who must also follow the same process.

Article 2 – Meetings and membership

Meetings

115. The party's meeting is called "**theatre of conversation**". The duration of each theatre of Conversation will not exceed 2 hours though people can stay on to socialise if the venue permits. Each Party book can hold as many theatres of conversation per month as they can manage.

116. The theatres of conversation are in 2 parts. The first part is a public event open to everyone and will be for a duration of 1 hour. The second part is a Party management event where the Party's officers discuss Party affairs including reports from officers and review of the general financial health of the Party.

117. At the end of the public part of the theatre of conversation, officers stay back to discuss any matters specific to the running of the Party generally or the book in particular. Minutes of the second part of the theatre of conversation must be forwarded to the London Office and to the Treasurer.

118. Each theatre of conversation will be well publicised but admission to the venue is subject to the hosting capacity of the venue, security requirements of the venue and the particular conditions of admission stipulated by the owner of the venue.

119. Theatres of conversation are collaborations between the hosting venue and the book organising the theatre of conversation. There must be at least 4 theatres of conversation in a year for every book in which a quarterly report of the Party's finances must be received and discussed.

120. For how decisions are made at the theatre of conversation please see paragraphs 112-114 above.

The National Books Gathering

121. The National Books Gathering is a bi-annual event which brings together the entirety of the Party's Books all over the country to meet in one town at a general Theatre of Conversation. Every part of the country in which there is an active Book will get a turn to host a National Books Gathering.

122. The date of the first gathering in a year must be in the middle of the financial year. The core Party business will be 2 hours in a venue which must be big enough to accommodate every representative of every Book. After the core Party business, the Books gathering events may continue in a plethora of diverse educational events, lasting longer than 1 day and depending on the demands of

space, held in different venues. It is mandatory that every Book (branch) of the Party is represented at the national Books Gathering.

123. The purpose of the 'Midyear' Book gathering is to nominate 2 auditors who will audit the party's accounts, receive the 'Midyear' Report from all Books, receive the Treasurer's 'midyear' report, exchange ideas, share stories of mistakes, growth and advancement, and discuss strategies for progressing the building of bridges of understanding. At each National Book Gathering the venue of the next National Book Gathering will be decided and the Chair for that next Gathering decided. If there are multiple members interested in hosting the next National Book Gathering or in being its Chair Person, the incumbent Chair of the National Book Gathering will cast a lot of all interested LOVEbearers and the individual, entity or Book which emerges from the draw will be the host or Chair subject to the approval of the Party Leader who will confer with other Party Officers before making a decision and must not withhold approval unreasonably.

124. The date of the last Book Gathering of the year is to coincide as far as possible with the date of registration of the Party with the Electoral Commission. However, if this date is close to the date of the Midyear Gathering, then the last Book Gathering of the year should be held after 5 months of the Midyear Gathering.

125. The purpose of the second Book Gathering is to elect new officers for the party, approve the party's Annual Statement of Accounts after it has been audited, receive the Party's Annual Report including reports from all Books and the Party's Treasurer, cultivate exchange of ideas, share stories of mistakes, growth and advancement, and discuss strategies for progressing the building of bridges of understanding.

Individual membership

126. Members are called LOVEbearers. Active membership is not determined by subscription fee as there is no subscription fee. Active membership is evidenced by attendances at the meetings held by books (theatres of conversation) and the giving of time and skill to advance the objects of the movement. Members are expected to read the constitution and to subscribe to its objects, aims, aspiration, principle and philosophy. Records of those who attend the meetings (theatre of conversation) are kept online and open to anyone to view.

Individual members of other political parties

127. The Party is seeking to unseat lack of LOVE. It sees the potential in every person, irrespective of political affiliation, in unseating own individual lack of LOVE. Diversity of thought is a human privilege and has created diverse inventions, associations and political parties. Touch LOVE philosophy recognises that each human is doing own best at any given time. It acknowledges the fact that each political party was created to protect and promote what its founders saw as fundamental human values, and the best way to create a better society and a better life for those whose interests are at its core.

128. The Party is not interested in destructive power-struggle. Its interest is in sowing LOVE. It is a party of '**all hands on deck**'. It wants to weaken money and strengthen individuals' inner resource by encouraging individuals and entities to store LOVE in mind, keep a LOVE account and have a bank of LOVE. It needs all hands to achieve its primary aim of persuading the populace and all political parties to come together and work towards instituting the rule of LOVE (Supremacy of LOVE) by voting for Touch LOVE Act. The Party is therefore affiliated to all those who choose

LOVE as their leader and welcomes every person to participate in its meeting (theatre of conversation) irrespective of membership of other political parties. This is because within the philosophy of Touch LOVE, every person, irrespective of membership of other political parties, is an 'inactive member' of the Touch LOVE movement who can become an 'active member' by attending the Party's meetings (theatres of conversation). Each human has the ability and capacity to act in a way which can unseat lack of LOVE.

Membership by non-individuals

129. All non-individuals and entities including businesses, colleges and places of learning and other institutions, associations, organisations, governments can become active group members. Active group members advance the Party's objectives and principles and are deemed to have read and accepted this constitution.

130. Entities who want to publicly identify with the movement and undertake specific tasks can make their intention known by contacting the London Office. The London Office shall keep a register of all entities collaborating with the party in advancing the party's objective. The record shall show all assistance the Party is receiving from the entity. The record will be online and accessible to anyone who wishes to view it.

131. Active membership is evidenced by the commitment to install the rule of LOVE not just in its working practices but in the collective aim of voting for Touch LOVE legislation. Entities who openly subscribe to LOVE are openly holding themselves out to be held LOVE-accountable to LOVE. Whenever asked to give account of own 'breathprint', the entity shall be read to give account of its Touch LOVE practices within its own internal system as well as its external dealings with others.

Classes of Party Membership

132. There are only 2 classes of membership.

- Those who attend **theatre of conversation** and are known as active members
- Those who do not attend **theatre of conversation** and are known as inactive

133. Those who attend the Party's meetings (**theatres of conversation**) become recognised as active members of the books in which the meetings are held and their names are recorded in the Book's membership record which records all attendances for every Party meeting (theatre of conversation). Every active member within this class of membership is deemed to have read and accepted this Constitution, including the Party's Principles and Objects.

134. Others who publicly identify with the movement, read the constitution including the Appendix and agree to be bound by the constitution are also recognised as active members but the Party does not keep record of such active members.

Article 3. Nominating Party Leader and officers

135. Every year, at the second National Book Gathering, the LOVEbearers attending the book gathering act in accordance with their LOVE to nominate and elect a LOVEbearers to hold Party Offices. Where there is a tie, the nominated LOVEbearers in the 'tie' are given an opportunity to discuss among themselves as to who should hold the Office and if a consensus is reached through this process, all the other nominated LOVEbearers in the 'tie' will gain and bear the title of

‘Supporting [the name of the office], for example ‘Supporting Party Leader’ or ‘Supporting Chair’. These are honorary titles only and bearers of the titles are not Party Officers.

136. If the nominated LOVEbearers in a ‘tie’ are unable to agree, a lot will be cast to determine who among all the nominated LOVEbearers will be the Party Officer and the title of ‘supporting’ title will not be gained or borne by any LOVEbearer.

Article 4 – Party Officers

Party Leader

137. The role of the Party Leader is to lead and represent the values of the Party and steer the Party towards achieving its aims and objectives.

Chair

138. It is the responsibility of the Chair to ensure that members know who is responsible for taking a task forward. The Chair holds other Party Officers accountable to the Party’s principles. Working with other officers, the Chair leads a review of Party structures and operation; organises the dates of meetings at least three months in advance and makes sure the dates are communicated to members, with a reminder closer to the time, sets an interesting and relevant agenda which will need to be circulated and agreed with the Secretary and other officers prior to the meeting, set a time limit for each agenda topic, gets hand-outs ready in good time, ensures that meetings do not last longer than two hours and organises a campaigning or fundraising event after the meeting.

139. The Chair provides leadership, openness and healthy atmosphere for team spirit, organises and inspires effective Party campaigns and oversees adherence to core Party values. The Chair also ensures that meetings are enriching experience, decisions are fair, a variety of voices are heard and that the Party operates fairly, justly and in touch with LOVE at all times. The Chair must be impartial and must be supportive of all Party members and participants at meetings.

140. The Chair ensures that no foreseen or unforeseen circumstance causes a deviation from the core principle and philosophy of Touch LOVE upon which the movement is founded. The Chair’s duty is to recognise that lack of LOVE is a real enemy which creeps in to infiltrate good intentions and to divert attention with baits which are easy to swallow. The Chair keeps away lack of LOVE and ensures that decisions are not corrupted by destructive self-interest which excludes and destroys others.

141. In implementing the Party’s values, the Chair engages in own self-development, LOVE-energy self-governance and mind-broadening exercises. To make own body and mind healthy and receptive of life-giving thoughts and be an example of what the Party represents.

Vice Chair (Membership)

142. Working alongside other Party Officers, the Vice Chair is responsible for devising a creative and effective way of spreading the principles and philosophy of Touch LOVE and increasing the number of active LOVEbearers while continuing to respect and value existing members, whether active or inactive.

143. The Party meetings take the form of THEATRE OF CONVERSATION and it is the responsibility of the Vice Chair to increase the number of people who attend the THEATRE OF CONVERSATION. As far as possible, the Vice Chair encourages active LOVEbearers to invite new people to come along to the THEATRE OF CONVERSATION.

144. The Vice Chair (Membership) ensures that each individual member has an opportunity to share own tales and feels deeply connected and involved in making the most of their membership. The Vice Chair's responsibility includes ensuring that education is at the heart of every activity and creates opportunity for learning from every member of the Party.

Vice Chair (Campaigns)

145. The Party is campaigning for what many may see as an abstract concept which is difficult to grasp in time and space. The role of the Vice Chair of Campaigns is to realistically organise an effective team of LOVEbearers who deeply understand the concept of Touch LOVE to explain the concept to the populace, answer their questions and invite them to be active LOVEbearers. So the first responsibility of the Vice Chair (Campaigns) is to study the published Volumes of MANY LOVERS BOOK 4267 and the principles and philosophy of the Party, understand the concept of Touch LOVE, practise it and organise training for all LOVEbearers who express an interest in working with the Vice Chair (Campaigns) to spread understanding of the philosophy of Touch LOVE. The Vice Chair (Campaigns) is responsible for organising self-development trainings for all Party Officers and any member who chooses to be trained in the workings of the Touch LOVE philosophy.

146. Successful Touch LOVE campaigns are creative and educational and are an all year round project not just a project that happens during the last few weeks before polling day. So it is the responsibility of the Vice Chair (Campaigns) to create a long term plan with short, medium and long term education milestones.

147. In addition, the Vice Chair (Campaigns) has the following duties:

- (1) Create a campaign plan that focuses on the next set of elections as well as the other elections to come
- (2) Learn from everyone and everything in creating an effective method of embracing and connecting communities in an engaging way which reflects real connection to the needs of each community
- (3) Show leadership but be willing to delegate and create a team
- (4) Motivate volunteers and develop the capacity/organisational ability on the ground, incorporating new campaign techniques
- (5) Identify talent in others, encourage and support those who want to get involved
- (6) Identify training opportunities and requirements
- (7) Be willing to take difficult decisions if the overall strategy demands it
- (8) Work closely with the candidates, elected representatives, Party Officers, and existing structures to ensure that an effective, coordinated campaign is delivered in the area.

Secretary

148. The Secretary of the Party ensures that agendas are publicised and circulated in good time so that participants will have sufficient time to prepare to discuss the issues at the theatres of Conversation including the National Book Gatherings. The Secretary keeps comprehensive record of minutes, gets the minutes circulated afterwards and ensures that any copies of any relevant correspondence is circulated alongside the minutes. The Secretary also circulates the self-nominations of candidates wanting to represent the Party at UK elections.

149. The Secretary works with the Secretaries of each Book (branch) who for the purposes of the constitution are the Secretary's Assistants.

150. The Secretary will also work with other officers to:

- (1) Put together a development plan, covering specific targets for community organising and capacity building.
- (2) Set up effective traditional and digital communication systems.
- (3) Devise and maintain accurate contact details and provide membership information to other officers as required.
- (4) Create an open and fair place communication system which values all contributions from members
- (5) To create a rich variety of regular activities and an enriching aura at meetings which will inspire free flow of information and ensure that all participants feel involved and valued and know the activities of the Party
- (6) To work as a team with other officers to provide opportunities for others to become involved, and to make sure community events and activities are organised to reach out into and involve people in the local community.
- (7) To arrange the time, date and venue for meetings in good time. You will have some functional business to go through at your meetings, but please make sure that the meetings are interesting, welcoming to new people and held in a friendly manner.
- (8) To ensure that lively debates at meetings focus on subjects such as:
 - (a) Campaigning for change in the local community and campaigning to get the right candidates elected at elections
 - (b) Recruiting new members, retaining and developing existing members and finding new supporters
 - (c) Policy discussions, making them interesting and engaging

LOVEbearer Officers and Head LOVEbearer

151. LOVEbearer Officers work closely with the Vice Chair (Campaign) and other Party Officers to ensure that the Party has the LOVE energy and resources it needs for campaign purposes by reaching out to other LOVEbearers and encouraging their active participation, organising 'LOVE TO ALL ALWAYS' installations and talking points, and compiling a programme of social events.

152. LOVEbearer Officers may assist in fund raising activities by liaising with the Treasurer to plan an effective programme supported by available resources. Every LOVEbearer Officer will wear a badge identifying them as a LOVEbearer Officer whenever they are conducting business for the party. In every party branch (book) there will be one Head LOVEbearer Officer who is responsible for coordinating the activities of all LOVEbearer Officers and who allocates individual duties to each LOVEbearer to avoid any confusion or misunderstanding. Every active LOVEbearer is entitled to wear a badge of LOVEbearer Officer and participate in the LOVEbearer Officers' work. Each LOVEbearer Officer is accountable to the Head LOVEbearer for any work conducted for the party. The Head LOVEbearer is accountable to the Treasurer.

Treasurer

153. The Treasurer is responsible for the whole party's compliance with the requirements of Political Parties, Elections and Referendums Act 2000 ('PPERA'). It is the Treasurer's duty (in collaboration with other Party Officers) to open a bank account in the name of the Party at a UK bank and to put in place a system of accounting which will enable the Treasurer to comply with the requirements of the PERPA. It is also the Treasurer's duty to ensure that no donation is sought nor

accepted in the name of the Party, and no donation scheme (whether online or otherwise) is set up in the name of the Party before a bank account is opened in the name of the Party and before a PPERA compliant accounting system is set up for the Party.

154. For the purpose of compliance with PPERA, the financial affairs of any local book or affiliated organisations of the party, whether currently existing or to be established in future, will be wholly controlled by the party Treasurer. Please see the attached Party's financial scheme (Appendix 2) which gives details of how the Party organises its financial affair.

155. The Party's financial year runs from 1 January to 31 December. The Party Chair is the Deputy Treasurer. It is the duty of the Treasurer to ensure that the Party complies with the party funding laws as set out in the Political Parties Elections and Referendums Act 2000 (PPERA) which regulates all aspects of the Party's finances. The Treasurer keeps accurate financial records throughout the year, produces an Annual Statement of Accounts and identifies and reports donations and loans at the end of each quarter.

156. The Treasurer is also responsible for identifying the financial need of the Party, maintaining the financial health of the Party, setting budgets and fundraising targets. The Treasurer is a signatory on all the Party's account and gives regular reports to the General Theatre of Conversation at least quarterly and whenever a significant financial change happens. The financial record must be open for viewing by anyone who asks to view and it is the responsibility of the Treasurer to be supportive of all requests to view any financial record. The Treasurer receives the bank statements and keeps record of all expenses. The signatories on the Party's bank account must be 3 or 4 current officers of the Party with 2 signatories being required on every cheque issued on behalf of the Party. The Treasurer must be one of the signatories on every cheque issued.

157. Auditors are nominated at the first National Book Gathering of each year. The Annual Statement of Accounts must be prepared and approved at the second National Book Gathering of each year. Two members act as auditors who should audit the accounts before they are approved at the second National Book Gathering. The Treasurer is responsible for sending a copy of the annual accounts to the Electoral Commission by 30 April. A fine is levied on the Party if this requirement is not met, so the Treasurer must ensure that all requirements are met well in advance of the deadlines.

158. Once the party is registered by the Electoral Commission, it must put in place a system which collates donations under their respective donors and creates alerts notifying the Treasurer of when a particular donor's donation and loan becomes more than £500 in a calendar year to enable the Treasurer to comply with the requirement of the Act and provide the Electoral Commission with relevant information to be published on their website.

159. It is the Treasurer's duty to register all monetary and non-monetary donations in a central register including online register and hard copy files. Transparency is mandatory within the Party's policy and it is the Treasurer's duty to ensure that the Party's financial affairs are transparent to the public and kept up to date. All donations and loans of more than £500 must be reported by the Treasurer in the Quarterly Donation and Loan Report records kept in the Central Office in London.

160. The Treasurer must report any donations or loans of more than £500 made to a Book (branch) and include total Book income and expenditure in the annual accounts and keep in regular contact with all assistant Treasurers. Every Book must have an Assistant Treasurer who reports to the Party's Treasurer. It is the responsibility of the Treasurer to liaise with all Assistant Treasurers and record all monetary and non-monetary donations. Things like printed materials supplied by an

individual or an entity, free use of office space or an event venue, gifts of equipment, publications, free use of premises etc must be recorded.

161. When donations are accepted by the Party, this creates a legal duty to check that the donor or lender is permissible. This means that the donation must be from a UK source. The checks on donors must be before the money is banked and must be carried out within 30 days of the donation being received or within 30 days of the non-cash donation being accepted. If the Treasurer finds out after the 30 days have elapsed that a donor or lender is not permissible, the donation cannot be returned but must be forfeited to the Electoral Commission. Lenders must be checked before the loan is made. Individual donors and lenders must be on a UK electoral register at the time they make a donation or loan. (UK does not include the Channel Islands or the Isle of Man). The Treasurer must seek guidance from the Electoral Commission if such guidance is needed at any time.

162. Companies must be incorporated, registered and trading in the UK. Donations or loans from charities or organisation funded by public money cannot be accepted. When a donation or loan is offered or made, the Treasurer should always take into account the political implications as well as confirming it is legally permissible. The Party is LOVE-resourced and its reputation in this regard is more important than any monetary or non-monetary gift, so it is the Treasurer's responsibility to uphold this Party's LOVE-resourced reputation by ensuring that acceptance of gifts does not damage the reputation.

163. It is the responsibility of the Treasurer to work with other officers to set targets and a schedule of events and activities which will maintain the financial health of the Party. Members must always be informed of how the Party is doing financially especially with respect to the budget.

164. A professional accountant's services may be engaged where it is necessary to assist the Treasurer to comply with the obligation under the Act.

Assistant Treasurer

165. The Party operates mainly on **LOVE-energy** and **LOVE-bank**. **LOVE energy** is the energy, time, space and skill invested doing work for the party by any individual or entity for no financial gain but purely out of the LOVE for the object of the party. The party does not call such investment of LOVE, time, skill or space a voluntary scheme. It calls it a LOVE scheme. It does not call LOVEbearers who invest LOVE, time, skill or space 'volunteers'. It calls them '**LOVE bankers**'.

166. **LOVE-bank** has two meanings. First, it means the joy one derives or 'banks' when carrying out LOVE work for the party. The second meaning is the '**LOVE-resource**' the party derives or banks or has at its disposal at any one time. Every individual or entity is a potential LOVE resource for the party but not all LOVE resources are active for the party. Only those who are active for the party are the party's LOVE resource. An active LOVE resource for the party is a LOVE bank at the time they are on the party's record as available and ready to offer and invest LOVE energy, time, skill or space to progress the aims and objectives of the party.

167. Every individual is a shape of LOVE which bears LOVE. This is why the party uses the title 'LOVEbearer' for every individual. Every individual who breathes is LOVED by the air inhaled which keeps the individual living in own particular unique shape. This is why the party uses the address '**Beloved**' or '**AirLOVED**' when addressing individuals.

168. The party's LOVE resource includes '**LOVE bankers**' who have pledged and on the party's record to always carry out certain types of work for the party without charge and who are on

the LOVE bank list of individuals/entities who always assist the party whenever those particulars skills are needed. This for instance could be professionals such as accountants who may pledge LOVE energy, time, skill and space to assist the party's treasurer to prepare quarterly accounts.

169. It is the party's policy to encourage individuals and entities to give LOVE energy, space, skill and time instead of money. It recognises that contributing LOVE energy, time, space and skill is more demanding than contributing money but prefers the inherent connection and understanding which flow from LOVE energy contribution. It is the party's policy to encourage connection through conversation and skill donation, to inspire connection and reconnection to the deep value of exchange of skills and people-energy and to promote sharing of space and learning of skills. The party values every contribution of LOVE-energy because it rejuvenates and maintains the LOVE-life of the party as it gets people to know and work with one another, and advance the building of bridges of connection and understanding.

170. In carrying out the duties of the Assistant Treasurer, it is the responsibility of the Assistant Treasurers to work within the framework of the party's policies to advance people's connection and the building of bridges of understanding. The Assistant Treasurer's duty is to assist the Treasurer to keep and maintain up to date record of all the party's LOVE resource, maintaining details of contributions and the monetary value where possible.

171. Each book (branch) of the party shall have an Assistant Treasurer who assists the party's Treasurer in keeping record of financial income and expenses of that party book (branch). The Assistant Treasurers directly report to the Treasurer but it is the Treasurer's duty to ensure that all records are accurate.

172. The Assistant Treasurer's duty includes recording the nature of the LOVE-energy contribution, the interest it yielded if any, and where possible, the impact on the bank of 'LOVE Energy, Time, Skill and Space'. The Assistant Treasurers and other officers are also responsible for persuading individuals and entities to become the party's LOVE resource.

Pregnancy And Placenta Officers (PAPO)

173. The PAPO's primary duty is to create awareness amongst the populace about the connecting force of the afterbirth. The PAPO represents every pregnancy and every afterbirth, giving a voice to every pregnancy and afterbirth. The Officer is an advocate bringing together everybody who was once a pregnancy, who was connected to a placenta and whose birth was followed by an afterbirth. It is a PAPO's responsibility to liaise with schools and other establishments in organising events for children of school age and creating thought provoking event in ante-natal clinics.

174. It is the PAPO's responsibility to explain to the populace, the reason behind involving children and actual pregnant women in politics. Though children are not voters, they are affected by the choice voters make, so their voices must be included, amplified and heard within the electoral process. Children are a valued constituency and a PAPO ensures that they are involved in running the government by helping them to understand the process, by interesting them with exciting stories to capture their attention and secure their participation, by inspiring them to engage and voice their originality and their thoughts on key issues and by ensuring that they know that they are valued and that their thoughts and ideas are very important and can create a better world. The intelligence of children are often under-represented or underestimated and it is the duty of the PAPO to ensure that such intelligence is not overlooked.

175. The PAPO will use age-appropriate materials to connect children to and involve children in the political process. This is a very important responsibility, so the role requires up to 10 or more

Officers to share the duty. The PAPOs will use their special skill, talent and uniqueness to devise the most engaging way to reach every child and mother who participates in the ‘Pregnancy and Afterbirth’ events.

176. The Party’s stance is that a political process is not just about campaigning to be in power but is as fundamental as food and whoever ingests food must have a voice in the process of food making and know what is poison and what is enriching so as to remove poison whenever encountered. Children eat what politicians cook and feed. This is why age-appropriate political education must start from the ante-natal clinics, continue through school-age to adult groups.

177. Political participation is so important and must not just be the main meal or pudding served only to children whose parents discuss politics at the dinner table but must be a staple food of every child as they grow up. Political participation must be viewed as a necessary part of growing up, and not made a preserve of a few children nor confined to only election campaign for power. Political participation must span all ages and all seasons because it is a life campaign for life.

178. The PAPOs also ensure that the voices of pregnancy, afterbirth and children are reflected in the Party’s policies.

Article 5. Nominating a candidate for political office

179. Every active LOVEbearer aged 18 years or above who is recorded as active in any of the Party’s book and who is registered on the UK electoral register and who wants to be the voice of LOVE in government can nominate self to be a candidate at the UK general or other elections by notifying own local book. The local book will then forward the self-nomination to the Party’s board members.

180. Upon receipt of the self-nomination, the Board will carry out consultation for the purposes of determining whether the LOVEbearer is an appropriate person to be the face and voice of the Party. To this end, the Party’s Secretary on behalf of the Board, will send out notices of the self-nomination to all the Party’s books including the candidate’s local book inviting LOVEbearers and representatives of every book in the UK to send their views, objections and support for the candidate. This notice can be sent electronically and announced on social media.

181. Following the consultation, a majority of the Board members must meet to deliberate on the information received on the appropriateness of the self-nominated candidate/s as being the face and voice of the Party. A majority vote will be sufficient to endorse the self-nomination and move the process to the next stage.

182. Where the board members endorse the self-nomination/s, the endorsed nominations will be put forward to a **theatre of conversation** where active members will vote for a candidate of choice where there are more than one candidate. The candidate with the highest number of votes will be nominated and where there is a tie, the same process which applies to Party Officers will apply.

183. The process of nomination must not be delayed and must be completed within 3 months starting from the date the notification was received by the local book. The Board must circulate the time table for completing the process at the same time it circulates the notification of the self-nomination to the books. The time table can be circulated electronically and announced on social media.

Article 6

Subscription

184. No money is required as subscription fee. In place of subscription fee, the Party requires people to answer the following questions:

Having read the key focus of the Party, as set out in this constitution including Appendix 1, will you vote for the rule of LOVE? If not, why not? If yes, why yes? Do you have a suggestion of how we can meet our aims and objectives? Can you lead or be part of the active LOVEbearers moving to realise the dream of one or more of the projects set out in this constitution?

Article 7 - Party finance

185. A single bank account will be opened in the name of the Party following registration of the Party by the electoral commission. All monetary donations must be paid into that account and all expenditure must be paid out of that account. The Party finance must be managed in accordance to the Political Parties, Elections and Referendums Act 2000. For the Party's financial scheme, please see **APPENDIX 2** below.

Article 8

Complaints and appeals

186. It is hoped that every LOVEbearer will put in practice what this constitution sets out to achieve and resolve differences of opinion or any conflict by contacting the relevant LOVEbearer and having a reconciliatory conversation. If the issue is not resolved, it can then be raised at the next THEATRE OF CONVERSATION of the relevant branch.

Article 9

Interpretation and amendment

187. This constitution remains work in progress and can be amended as situations demanding its amendment arise. Terms have been interpreted within the paragraphs but if any part of this constitution remains unclear, London Office can be contacted.

APPENDIX 1 – PARTY’S AMBITION

This Appendix contains the explanation of the Party’s ambition in the areas of Housing and LOVE village, Immigration, Health Care and general well-being, Economy and Wealth Creation, Crime reduction, Breathprints and Education.

HOUSING

1. When population expansion exceeds available affordable housing, a housing crisis occurs. Population expansion in a particular location, is at the root of accommodation crisis in that location. From time immemorial, land has always been a treasure which all earth beings cherish. It is precious to birds as well as to farmers. This is why territorial expansion and control is not just a preserve of human beings but also of other earth beings. Lions try to control their territories so do roosters. People follow their instincts to search for better quality of life and some migrate with the weather.
2. Accommodation crisis happens because people gravitate to places where living conditions are reputed to be better. Some towns and locations are more attractive and popular than others and seen as more progressive and more generous in terms of giving individuals opportunities to achieve their ambitions. Making less attractive towns more attractive places to live is one way of tackling accommodation problem at its roots because what happens in one part affects other parts.
3. The Party calls on individuals to work with it towards creating affordable homes and offices using shipping containers. This will guarantee accommodation to those who have none and ensure that no person is homeless in a place the person calls home.
4. Providing basic shelter is not the same as meeting the need for preferred location or fulfilling the ambition for a particular lifestyle, or a particular style of architecture. Basic-need accommodation will be guaranteed to any person who needs it and can be temporary or permanent according to circumstances. The vision is to make shipping container homes and offices more attractive than bed and breakfast accommodation. It will also be more economical to run and to maintain. Part of the fund presently used for bed and breakfast accommodation will be channelled towards creating these new homes and offices.
5. More towns will be made more attractive destinations for both tourism and for residency. Encouraging movement away from congested areas and promoting tourism are at the core of the Party’s policy.
6. No one should be without a sleeping space or be homeless in a location they call their home. LOVE villages will be created with efficient affordable transport system. Journeys to and from destinations outside of the centre will be made easy so that people can easily travel and mingle to meet their needs.

LOVE VILLAGE

43. LOVE VILLAGE is an inclusive community which will have a school, a hospital, other health care centres, police and other essential services. Everything in the LOVE Village will have a LOVE. Examples include:
 - LOVE NUDE - A community where nudists/naturalists live and work in safety

- LOVE CRESCENT - A section for out-door personalities who choose outdoor sleeping as a way of life and do not want the responsibility of having an accommodation in a house
- LOVE ROAD - A safe place for addicts of all kinds. This section will be equipped with appropriate health care services and will have the police station and police patrol services to ensure the safety of users, visitors and occupiers. Addicts are often exploited by reason of their addiction. By creating a LOVE ROAD community, it is hoped that it will assist to some extent in protecting addicts who are on the road to recovery. The plan is to fund this service with the compensation paid by those convicted of drug-related crimes.
- LOVE MEWS - There will be a section which will be a home for people on the streets who have no other home but the streets; equipped with health care services and good food
-
- LOVE STREET - Designated LOVE streets will offer accommodation of self-contained sleeping rooms made out of shipping containers.
- Flowers and trees will beautify and energise the LOVE lanes, mews and crescents.

44. In every community, there will be a TOUCH LOVE CENTRE which will include:

- LOVE STOP – place of flowers and scents where people may stop to refuel their LOVE level
- LOVE HEALING CENTRE (including preventative medicine centre, gym/sports centre, Theatre/Cinema, Doctors' surgeries including physiology and mental health healing centre)
- LOVE STAND-Where people stand to make speeches about LOVE
- DESERT LACK OF LOVE – a place to contemplate the problems caused by lack of LOVE over the years including wars and corruption
- **TOUCH LOVE WALL - THEATRE OF CONVERSATION:**
SPEAK TO THE WALL. A place where all inner walls are covered with whiteboards to encourage people to write their thoughts on the whiteboards. Writing own thoughts on the wall becomes a kind of performance. It is a place for people who want to speak their minds but have no one to speak to. There will be a 'wall' to speak to, a stage and a sitting area where people can sit if they want to listen to the speaker or converse with the speaker. The speaker has a choice to be anonymous or to be known, to have the lights on or off, to be visible, shadowy or invisible to anyone sitting to listen, to engage in conversation with listeners or to just hear own thoughts. The need for conversation is a fundamental need. As people are isolated by circumstances, the need becomes more pressing
- There will be a section which will be an art centre and a meeting place for artists. A section will be devoted to graffiti art.

45. Under the Party's policy, sleeping rooms can be created within weeks to meet varying accommodation needs. The Party's policy is that no one should be homeless or seen as homeless on this earth called home. At birth, every human dragged in own land known as the afterbirth or placenta. That land known as afterbirth is the first land owning of every individual. Therefore, any manure-producing and air recycling human has a sleeping place secured by the produced manure (faeces and urine) and the dragged in land - the afterbirth. Afterbirth is the land upon which every

home is built and it is impossible for anyone whose birth was followed by afterbirth to be homeless. So wherever one finds oneself is one's home until one is in a position to change that position. The Party's policy is to ensure that every space is a comfortable home at any particular time that anyone has that space as home.

46. Some shipping container made into comfortable sleeping rooms can appear on certain streets every night and be removed every morning. People of any age can stay in the LOVE villages until they can afford to move. Those who are able and who have transferable skills, will maintain the accommodation by an exchange of skills if they cannot afford to contribute money towards running cost.

LOVE VILLAGE CONCEPT

47. Within the RULE OF LOVE, nomadic lifestyle is accommodated and valued and there will be a designated area for this within the LOVE village. There will also be designated areas for people who choose to live a life of nudity in a forest environment, planting their own crops. The concept is to create an inclusive society where nudity is not seen as vulgar but where people are safe and not sexually harassed and abused.
48. LOVE-energy giving centres will include open spaces where creativity is practised. Music, dance and art centres will also be part of the energisers. Artists can use space free of monetary charge but will be required to invest their skill to maintain the centre and offset running cost. Maintenance training will be available for this purpose.

LOVE-BASED EDUCATION SYSTEM

50. The Party calls on everyone to help create a LOVEbased education system. Starting from the perspective that within a wider community is where the success of an education system manifests and thrives, the Party seeks to work with all educational institutions and ante-natal clinics in exploring LOVE-centred education system where the focus moves from going to school in order to get a job to going to school for LOVE development and advancement and to learn how to create self into the unique entity personal passion can evolve to be.
51. Within its concept, the Party sees a school as an assemble of mixed abilities, a place where mixed ability teachers learn from mixed ability pupils, and where a system of education designed to inspire both learner and teacher to realize own full potential and play to own strength is legally implemented and supported by all stakeholders and collaborators.

DEPARTMENT OF LOVE – A NEW GOVERNMENT MINISTRY

52. The Party will create a new government ministry called Ministry of LOVE which will oversee and coordinate LOVE education from ante-natal clinics. It will bear the responsibility of implementing the 'LOVE-based education' provisions of the new 'Touch LOVE Act' including the provisions on the 'afterbirth or placenta'¹celebration days. The Ministry will also bear the responsibility of creating awareness and highlighting the important position of pregnant women and all parents in assisting to achieve a

¹ Afterbirth or Placenta is an organ created to support pregnancy and is a symbol of LOVE within the Touch LOVE philosophy. Educational programme called 'Afterbirth Worldwide' highlights the significance of afterbirth.

world where LOVE rules and where the role of money is questioned and the passion for money acquisition is no longer the cause of wars.

53. Re-education is at the heart of the rule of LOVE. The philosophy of Touch LOVE aims to engage thoughts in the many diverse sensitive subjects which divide humans as well as the entrenched practices which treat some as inferior and which by so doing, damage earth beings including human beings. Ministry of LOVE will also aim to inspire a re-thinking into established belief systems.
54. University of Touch LOVE Worldwide will continue in its present form and people from around the world can access the philosophy at no monetary charge.

ECONOMY

55. Centres of LOVE will be established to be at the heart of every institution including government departments and all businesses and business models.
56. Rethinking models of economic growth will be central to reforming collective values. The Party will review length of working hours to work out a balance that is healthy for individuals, families and communities. This review may result in people working less hours. It may also result in work shares to benefit skilled but unemployed people. The review will include hours and pay of the executives as well as non-executives. Humans do not need a large amount of money to live a happy and fulfilling life. A successful economy is one where workers have balanced life between home and money-making.

JOB CREATION

57. Establishing a Ministry of LOVE, LOVE village and Touch LOVE centres will not only create ways of occupying the mind, but also provide a nourishing environment and an enriching source of inner wealth and income as well as monetary income.
58. People are getting more and more isolated and many workers are stressed and full of complaints. Many people prefer to live a simple life where they work for few hours. However, few can do so because of the financial burden they bear. By creating a LOVE village which gives people a choice to live a simple life with little or no financial burden, there will be fluidity in jobs as people can take time off work more easily.
59. The LOVE village will create a connected society which invests in friendship and the exchange of skills. That, in itself, will create healthier minds and bodies, as well as, less stressed people in a community where money does not rule but where LOVE rules.

HEALTH CARE

60. A good health care prevents illnesses, connects individuals, and highlights additional sources of energy. Food is not the only energy source for the human mind or body. Conversation, for instance, is a very important energy supplier, does not have to cost money and does not have to be had over a meal or a drink because it is a meal in itself. Highlighting the concept of 'food abuse' is one of the ways the Party seeks to prevent illnesses and reduce pressure on the National Health Service. Food is medicine and any medicine can be abused. Even healthy food can become poison when abused. Food abuse is a sort of drug abuse. Food is to be enjoyed not abused and this is true for all kinds of energy givers including conversation, air and water.

61. Given the current pressure on the National Health Service and the waiting time for medical appointments, people will be encouraged to learn about their body and about healthy herbs and other measures which will help prevent the need for frequent hospital or GP visits. Establishing self-healing centres on high streets and in supermarkets is key to the prevention programmes. Blood pressure measuring machines, weight measuring scales, glucose level checker, cholesterol level checker and other such monitors for preventing serious illnesses will be made available and easily accessible so that people can check their state of health and self-refer themselves to the self-healing centres.
62. Learning from the trees and animals which self-heal by intuitively connecting to the medicine they need, the Party has already started running free talks on foods that harm and foods that heal. The program which is on-going in London continues to assist participants to identify and change destructive lifestyle. It is in collaboration with Clapham Law Chambers and is hoped to expand to involve organisations willing to fund such a collaboration by providing space for the event.
63. Human body is intelligent and self-heals if minds work well with it. Given the pressure on National Health Service, educating people about their bodies and how to help it work best, is a solution which will take the pressure off the NHS by preventing avoidable illnesses.
64. The Party looks at why some health systems failed including the secrecy of the past which caused loss of vital information because the secrecy meant that such vital information was not passed on.
65. Food can be medicine, nourishment, pleasure or poison depending on how it is used. There are different energy providers. Food is not the only energy provider and it is important to highlight this fact and encourage individuals to create own unique menu choosing 'meals' from all energy providers. A hobby for instance is a kind of meal and so is conversation. Hobbies, for instance, provide energy which lifts and quickens the body.
66. At the heart of health care reforms, the rule of LOVE will deliver a focus on building on on-going current drive towards mass education focusing more on self-administered preventative medicine, making everybody own doctor, recognising that everybody is a born healer of self and of others and have basic intelligence to be a doctor to self and to others. We learn biology, food nutrition and home economics at school but there is no continuing education on these very important aspects of health care. Individuals need to be continually educated on this vital part of health care if we are to prevent serious illnesses overburdening the NHS.
67. Animals intuitively avoid eating food which harms them including poisons. Humans have similar basic LOVE-instinct. Within the rule of LOVE, first aid will be taught to children and to adults. It has been long recognised that children are intuitive and intelligent and can understand more than previously acknowledged by the wider society. Building on the knowledge that in the present living arrangements, a child may be the only person to help an adult in an emergency, children will be taught how to use the telephone to seek help. Adults of all ages will be required to learn basic first aid to equip them with the skills to assist others when there is no other way of saving those on their way who have cardiac arrest and other sudden ailments.
68. The importance of herbs and the use of them will be taught from very early on in a child's life, highlighting the benefits of listening to the body and working with the body. These are just a few examples.
69. Pregnant women and parents will be involved in this work as their contribution in educating those in their care are immeasurable.

WEALTH

70. A conscious effort will be made to teach the new definition of wealth, helping people to understand that LOVE is the greatest wealth. It is because money has been placed at the helm of affairs that people fight one another and go to war to amass money. Having money is not the same as being wealth. LOVE is wealth.
71. Money is not bad in itself but the fact that money has acquired the status of ruler is at the root of many incidents of war, isolation and disconnection.

DIALOGUE

72. Prevention of crisis is at the heart of the philosophy of Touch LOVE philosophy so a 'Ministry of religion' will be established. Every religion and non-religion will be represented for the purposes of building understanding and respect. What is a religion? The definition is wide to include any human practice. So any human who has a passion and lives that passion has a religion. A passion which moves a human to live a particular way of life is a religion. It is often the clash of passions that causes wars, fights and conflicts. The definition of religion therefore includes individual practices and collective beliefs. Ministry of religion's responsibility is to continue the general drive towards building bridges of understanding in times of peace to prevent occurrences of war.

IMMIGRATION

73. In 2011, an individual who arrived here when he was 9 years old and was being deported when he was 26 years old was wailing in the plane when the plane engine was running in readiness to take off. This person was calling on the pilot, the passengers and the barrister who once represented him in court to come to his rescue. He was surrounded by immigration officers using some force to enforce his removal. This person preferred to spend his life in the U.K prison where he had been residing for some years than to be free in the country to which he was being deported. This happening raised the question as to why a person will prefer a life in prison to a life of freedom. The person's own words included the phrases 'here is my home', 'I will be killed there'.
74. This episode was to trigger a search for an immigration solution which recognises that what happens in one part of the world affects all of the world and which seeks to find the root cause of unwanted migration and find a more lasting solution.
75. The Party calls on people to explore to understand the root of migration. Generally, meeting new people entertains human spirit and people are accommodating of people whom they do not see as threats to their livelihood or happiness. In fact, people want to be surrounded by those who make them feel good in themselves.
76. Ordinarily, people on the street are welcoming. What is now manifesting as hostile attitude to immigration includes what may be termed as a reaction to what is seen as an unfair and unjust jumping of the queue.
77. UK residents are known for their loyalty to queues and frown upon any jumping of it; so, when priority housing goes over the heads of those who have been on the housing allocation queues to those new arrivals who are in priority need, something unpleasant is aroused in those whose places on the queue are affected. This unpleasantness ripples beyond those people into a wider community.

78. When people have to wait for months for medical appointments due to shortage of resources and increased population, it creates something unpleasant. With this in mind, a just and fair system which recognises these underlying causes of unpleasantness needs to be put in place.
79. In Immigration Tribunals, those who have lived in the UK for years without working or without having permission to work, rely on the many years they have been in the UK to ask to be allowed to continue to live in the UK. Some exhibit evidence of treatments which they have been receiving free of monetary charge, some exhibit the fact that their children have been to schools in UK for years, free of monetary charge.
80. One solution which the Party advances is to amend the immigration legislation to include a stipulation which provides that anyone who applies for leave to remain in the UK and relies on the free services received, is to be made to refund the value of such used services on the basis that such unauthorised use constitutes unjust enrichment.
81. It is unfair for some people who applied for leave to remain from outside the UK and granted such leave on condition that they pay for medical treatment or school fees to be paying school fees and hospital fees whilst those who had no leave to remain use the education and health services free of charge.
82. One of the reasons why people come to the UK is to benefit from the free education and free health care and in some cases, accommodation paid for through housing benefit. UK will welcome integration under a fair and just system which does not encourage unjust enrichment of some to the detriment of others.
83. The Party will create international policies that will work well with other countries to create worldwide awareness about the regressive life of those who are in the UK without permission to work. Social media will be used to reach people.
This idea is based on the fact that many people who leave their countries in search of a better life in the U.K do so without realizing how difficult life could be for those in the UK who have no permission to work. The Party will call on individuals to help in highlighting the plight of those who are in the UK without permission to work.

TACKLING VIOLENCE

82. A kind of dysfunction feeds violence. This dysfunction within the Touch LOVE philosophy is seen as a kind of sickness. There is a kind of madness which creates violence. The reason why incidents of violence make news is because violence is considered to be abnormal. No sane person chooses violence; a kind of madness chooses sane persons, corrupts their minds and changes them into violent entities. The phrase 'he/she got mad' reveals a deeper meaning. There are cases in which violence can be seen as a 'madness-infection' causing all kinds of destruction. 'Violent-madness' does not discriminate and the person using violence is violence's first victim. Violence is not a permanent state, but a state of being at a particular point in time. That state can change. Madness unfortunately, is a human illness which will remain for as long as illnesses remain. A kind of madness causes war and this is why war remains and has been witnessed by different generations.
83. People who use violence are weak. At the time of using violence, their LOVE faculty is blocked, causing them to lose the sense of power, losing control to violence and mistaking acts of violence as a solution. Recognizing this fact will create a new approach to the way violence is tackled.
84. Some mad people are locked away. Some are sedated. Some roam the street. Some are overpowered and restrained by emergency services. Some break loose, and like a badly wounded

snake, they spill blood here and there as they violently gyrate in pain. In that state of violent gyration, they cause destruction to whatever is around.

85. By calling violent attacks what they are and grading them into levels of madness, one will be tackling violence at its root. A person convicted of violence will be labelled 'mad' not just labelled 'a criminal'. The person will receive a pronouncement of the level of madness found to have been suffered and the level of the person's state of lack of LOVE. People will be declared as having been possessed by a class of madness for example class 2 madness or class 3 madness. It will be part of the judgment and sentencing will reflect the class of madness. Those who admit to being mad at the time of the violent act will get a sentence which will reflect this admission. Every person who is convicted of an act of violence will be given a choice to write and submit a paper on violence and how to tackle it at the root. Those who cannot write but can talk, will be given a recording instrument to record their own presentation. In addition to the present education being given in prisons, there will be a choice to engage with Touch LOVE philosophy and activities.

BREATHPRINT - THE NEW CONCEPT

86. 'Breath print' is the invisible imprint or drawing a human's breath makes or becomes when exhaled. The concept stems from the fact that a human's breath connects the human into the outside pool of air, deposits the internal print of the human into the air and expands the human beyond the encasement of the body.

87. Each breath is unique; each carrying traces of internal uniqueness of the body from which it emanates. The DNA the breath deposits into the pool of air outlives the human body. The idea is that the breath deposited by people who lived over 5000 years ago are still mingling in and out of breaths. A breath is the most intrusive of all things. It gets into parts which other things cannot get and touches what other things cannot reach. It cannot be seen with the naked eye but its importance cannot be disputed. If one accepts this notion of the breath reaching every part and holding information on every part, one can self-govern better, and give deeper thought into one's own exhalation both in words and in action.

88. Given that we now walk on pavements and cannot leave our footprints behind because of shoes, a breathprint is a fundamental part of self-governance. We cannot shoe our breath and our breath remains one naked part of us that we cannot do much to clothe or cover not even by using breath fresheners.

BENEFITS

89. First, it makes living an art and breathing a living art. One can actually print out and exhibit own breathprint or breathpath and be proud of what it shows.

90. It can be used to monitor pollution and can be fitted with an alarm to go off when in a pollution zone, helping people to look after their lungs better and putting pressure on the State to clean out air polluted areas.

91. We want to inspire and encourage the creation of a breathprint app. Breath is so important but we do not pay attention to our breath as much as we should. The breath is the root of everything. If a breath counter is fitted to the breathprint app, we will know how many breaths we take and how much LOVE we owe; measuring actions and words by breath units.

92. The breathprint is one way of evaluating what one leaves for posterity on the paths one uses throughout life. The Party will inspire the exploration of the new concept of 'breathprint' by

inspiring the creation and the putting in place of ‘breathprint mapping app or similar gadget’ for mapping an individual’s daily ‘breathprints’. The gadget or app can be in the form of a wrist watch or be inserted on a phone or other such gadgets. Individuals can use the breathprints for different purposes including tracking own ‘LOVE print’ and identifying points of low or high spirit; or points of high or low energy.

- 93.**Breathprints tracking device can also be used as a ‘LOVE account’, showing where one deposited own DNA and exploring what interest it makes. Further, just as a car’s mileage is used to know when a car is deemed to be due for servicing so can an individual use a breath count to monitor own health and servicing.
- 94.**Breathalysers measure alcohol levels in breath, step-counting wrist watches measure number of steps an individual takes whilst wearing it, so, there is no doubt that humans who invented these gadgets and apps are capable of inventing a gadget or app which can show a map of the path of breaths.
- 95.**Mapping out breath paths can be beneficial in more than one way. If we fully tap its resources, it can help in crime prevention, in illness prevention including mental illness prevention, in accident prevention and will improve general wellbeing and connections. If people know that the land tracks their movement, and that their breath prints record their activities, they will respect the land and their breath, and enjoy deeper connection to both.
- 96.**I do not know why infrared comes to mind but if breath is given a colour and we create a colour detector for breath, we can easily see the energy exhaled by a person on paths passed by the person. Trained dogs can sniff out a person through invisible indicators because they can see what we cannot see and perceive what we cannot perceive. There are things out there which the human eye cannot see which other earth forms can know.
- 97.**The Party seeks to implement this idea of breathprint and aims to inspire a move in the directions of breathprint mapping, and donation in breath units. Our policy is to encourage people to give time, LOVE-energy and skill instead of money. However, for this project, we are being asked to allow financial funding to cover research of this idea and to cover the creation of breathprint mapping gadgets or app.
- 98.**Aspiration and passion are the parents of inventions and we can make this idea happen if we have enough passionate creators investing their LOVE-energy to make this app. The human LOVE-energy can create what was once thought to be impossible. We have enough talented creators in our midst to take on this project and give birth to an app. We are putting this idea forward because we know that there are brains out there equipped with greater insight into how this can be realised. We accept that we do not have the answers and that our role is limited to putting out the idea, and encouraging anyone who takes on its research. The main concern of course is the likelihood of an abuse by a State of this idea, the risk of breach of an individual’s rights to hoard their breathprint maps. We are prepared to start this project, learn along the way, make mistakes and build on learnings from the mistakes; bearing in mind at all times the concerns about abuse and working to see how to resolve that concern.
- 99.**We do not encourage donation of cash but need a giving of time and skill, and in actual fact, we see such giving as a fulfilment of a duty we owe to our breath. For researches such as the ones which the concept of ‘breathprint’ requires, we seek funding. Such researches will include but not limited to exploring ways to create the breathprint gadget or app. One major concern is where the app will be positioned. Can it be a nose ring, a necklace, a wrist watch, inserted in a phone or gadget-less

and wireless? These are questions which we do not have an answer for at this stage but which research and tests will provide answers.

189. The following thoughts have been included to illustrate the kind of thoughts discussed at the THEATRE OF CONVERSATION and to help a reader of this document to understand the educational work which the party is doing.

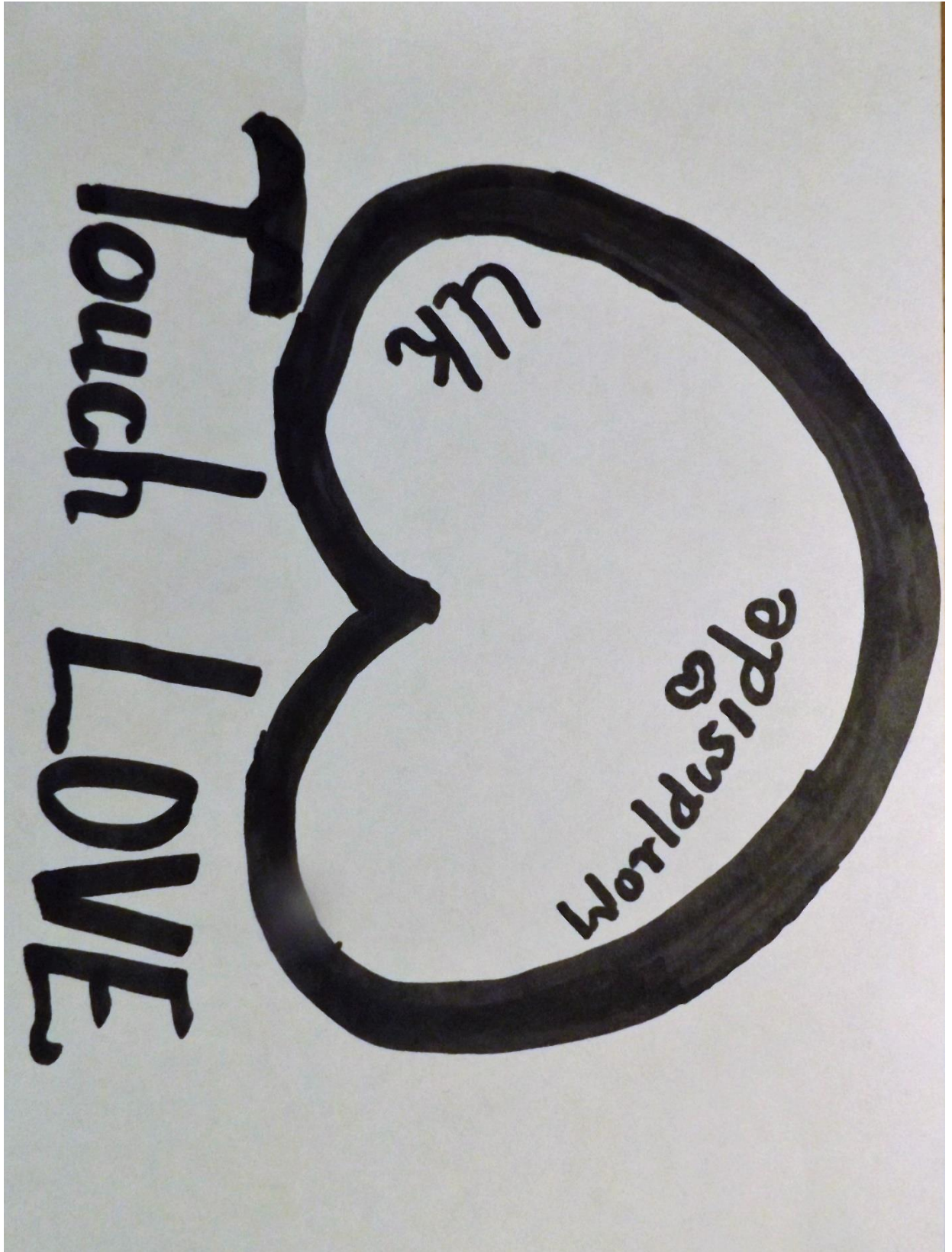
WHO STARTED THIS?

APPENDIX 2 - Financial scheme for TOUCH LOVE WORLDWIDE (UK)

Introduction

1.1 This scheme sets out how **TOUCH LOVE WORLDWIDE (UK)** ('the party') will organise its financial affairs to comply with the Political Parties, Elections and Referendums Act 2000 ('the Act').

Constitution

1.2 A copy of **TOUCH LOVE WORLDWIDE (UK)** constitution, setting out our structure and organisation, and how we take decisions about the management of the party, is attached to this scheme or has been provided separately to the Electoral Commission.

Accounting units

1.3 The **TOUCH LOVE WORLDWIDE (UK)** does not wish to register any separate accounting units with the Commission.

Organisations within the party

1.4 For the purpose of compliance with the Act, the financial affairs of any local branches (also known as books) or affiliated organisations of the party, whether currently existing or to be established in future, will be wholly controlled by the party treasurer.

Financial year

1.5 The party's financial year will run from 1 January to 31 December.

Role of the party treasurer

1.6 **Harriet Gore**, the registered treasurer of **TOUCH LOVE WORLDWIDE (UK)** is responsible for the whole party's compliance with the requirements of the Act, including the following:

Annual accounts

1.7 The **TOUCH LOVE WORLDWIDE (UK)** will submit our annual statement of accounts to the Commission by the required date, being 30 April of the year following the end of the financial year if both our expenditure and income are under £250,000 in that year, or 7 July of the year following the end of our financial year if either our expenditure or income exceeds £250,000 in that year. We understand that if our income or expenditure exceeds £250,000 our accounts must be submitted with an auditor's certificate.

1.8 In order to comply with this requirement, **the treasurer, Harriet Gore** has:

- put in place arrangements for ensuring that annual statements of accounts for the party are prepared, approved, audited where necessary and submitted to the Commission by the prescribed deadline for each register the party is on
- put in place accounting processes capable of meeting the Act's accounting record keeping requirements and of any regulations made by the Commission about the format of statements of accounts

Donations and Loans (regulated transactions)

1.9 **TOUCH LOVE WORLDWIDE (UK)** will report the donations and loans it receives each quarter to the Commission, for each of the registers it is registered on, within the following timescales:

- quarter 1 (1 January – 31 March) by 30 April of that year
- quarter 2 (1 April – 30 June) by 30 July of that year
- quarter 3 (1 July – 30 September) by 30 October of that year
- quarter 4 (1 October – 31 December) by 30 January of the following year

1.10 In order to comply with this requirement, **TOUCH LOVE WORLDWIDE (UK)** will:

For donations:

- record information for all donations of more than £500, including:
 - amount or value of the donation
 - full name of donor
 - registered address of donor
 - company registration number (if applicable)
 - date on which the donation was received
 - date on which the donation was accepted or returned

- information about the trust (if applicable)
- check the permissibility of any donations over £500 within 30 days of receipt
- ensure that impermissible or unidentifiable donations of more than £500 to the party are recorded as outlined above and returned to the sender or financial institution that transferred the money or, if that is not possible, surrendered to the Commission
- ensure that a submission of quarterly donation reports covering donations exceeding £7,500 (including aggregates of donations and regulated transactions) and any impermissible or anonymous donations of more than £500 is made to the Commission within the above timescales; submitting a nil return if there are no reportable donations¹
- provide weekly donation reports to the Commission during UK Parliamentary election campaigns if we are contesting the election

1.11 We understand that if we submit four consecutive quarterly nil donation returns, we will then be exempt from submitting further quarterly returns in respect of donations until we receive a reportable donation.

1.12 We also understand that separate quarterly donation returns must be submitted if we appear on the Northern Ireland register of political parties.

For loans (regulated transactions):

- record information about all regulated transactions (loans, credit facilities, etc.) including:
 - value of benefit of the transaction
 - name of all authorised participants
 - registered addresses of participants
 - company registration number (if applicable)
 - nature of the transaction
 - date agreement entered
 - the terms of the transaction
- ensure that the party does not enter into any regulated transactions with unauthorised participants
- ensure that a submission of quarterly transaction reports covering transactions exceeding £7,500 (including aggregates of donations and regulated transactions) and any void transactions or transactions of more than £500 entered into with an unauthorised participant is made to the Commission within the prescribed timescales; **submit a nil return if there are no reportable transactions**
- ensure weekly regulated transaction reports can be submitted during UK Parliamentary election periods if we are contesting the election

1.13 We understand that if the party has submitted **four consecutive quarterly nil loans returns**, we will then be exempt from submitting further quarterly returns until we enter into a reportable loan.

1.14 We also understand that separate quarterly loan returns must be submitted if we appear on the Northern Ireland register of political parties.

Campaign expenditure

1.15 The party will submit a campaign expenditure return if we have candidates contesting a UK Parliamentary election, European election, Scottish Parliamentary election, National Assembly of Wales election, or Northern Ireland Assembly election. The campaign expenditure return will be submitted within three months of the date of the election if our expenditure is less than £250,000 or within six months of the date of the election if our expenditure exceeds £250,000. We note that if our expenditure during the campaign exceeds £250,000 our return must be submitted with an auditor's certificate.

1.16 In order to ensure compliance with the legislation, the founder and treasurer, **Harriet Gore** will:

- ensure that campaign expenditure and claims payments are duly authorised, received and paid on time and that all relevant receipts and invoices are kept
- put in place budgeting and monitoring arrangements to ensure that campaign expenditure is within the statutory limits
- ensure the compilation, auditing (if necessary) and timely submission to the Commission of a campaign expenditure return within the statutory deadlines

Referendums

1.17 If the party participates in a referendum to which Part VII of the Act applies, **TOUCH LOVE WORLDWIDE (UK)** will develop and put in place arrangements for complying with the controls on referendum expenditure. We will do this by adapting our arrangements for the control of campaign expenditure.

Grants

1.18 **TOUCH LOVE WORLDWIDE (UK)** will ensure that any grants from the Commission to the party are spent in accordance with the conditions of grant imposed by the Commission. We agree to cooperate with any associated audit requirements specified by the Commission. Changes to registered details

1.19 **TOUCH LOVE WORLDWIDE (UK)** will ensure that the party's details that are registered with the Commission are kept up to date. We will inform the Commission of any changes to registered officers within 14 days of the change and any other changes within 28 days.

1.20 We will ensure that our RP8 annual confirmation of registered details and £25 fee are submitted to the Commission with the annual statement of accounts by 30 April of the

following year (if our expenditure or income is less than £250,000) or by 7 July of the following year (if our expenditure or income exceeds £250,000).

1.21 We note that failure to submit our RP8 annual confirmation of registered details within the prescribed timescale will result in our statutory removal from the register of political parties. We understand that this would mean that the party would no longer be able to field candidates at elections under the party name.

Penalties and offences

1.22 **TOUCH LOVE WORLDWIDE (UK)** understands that the Commission may impose civil penalties on parties that fail to comply with their legal obligations, including failures to submit statutory returns on time. The party also understands that failure to comply with certain legal requirements of being a registered political party is a criminal offence.

Role of other party officers

1.23 Should the appointment of the registered party treasurer terminate for any reason, then the registered party leader will, until a new treasurer is appointed, be treated as the party treasurer and will be responsible for ensuring that the party complies with its legal obligations.

1.24 Should the treasurer whose appointment is terminated also be party leader, then the nominating officer will, until a new treasurer is appointed, be treated as the party treasurer.

1.25 Should the treasurer whose appointment is terminated also be party leader and nominating officer, then the other registered officer will, until a new treasurer is appointed, be treated as the party treasurer.

Promoting compliance with the Act

1.26 The Party will have processes in place to ensure compliance with its legal obligations. The registered treasurer, **Harriet Gore**, will ensure that the registered leader and all other officers and members of **TOUCH LOVE WORLDWIDE (UK)** have sufficient knowledge of our financial obligations under the Act to ensure that the party as a whole complies with these obligations.

Amendments to the financial scheme

1.27 The registered treasurer, **Harriet Gore**, will ensure that any proposed amendments to this financial scheme are submitted to the Commission for approval.
